ABSTRACT

Existence of Static Vacuum Extensions for Near-Schwarzschild Spheres: A

New Approach to the Bartnik Extension Problem

We establish the local well-posedness of the Bartnik static metric extension problem for arbitrary Bartnik data that perturb that of any coordinate sphere in a Schwarzschild $\{t=0\}$ slice. Our result in particular includes spheres with arbitrary small mean curvature. We introduce a new framework to this extension problem by formulating the governing equations in a geodesic gauge, which reduce to a coupled system of elliptic and transport equations. Since standard function spaces for elliptic PDEs are unsuitable for transport equations, we use certain spaces of Bochner-measurable functions traditionally used to study evolution equations. In the process, we establish existence and uniqueness results for elliptic boundary value problems in such spaces in which the elliptic equations are treated as evolutionary equations, and solvability is demonstrated using rigorous energy estimates. The precise nature of the expected difficulty of solving the Bartnik extension problem when the mean curvature is very small is identified and suitably treated in our analysis.

We consider the Bartnik static metric extension problem, which originates in the Bartnik mass-minimization problem, [Bar89, Bar97]: In the latter, one considers a topological 3-ball (B,g) equipped with a Riemannian 3-metric of positive scalar curvature. A natural example of such a metric arises on any compact space-like maximal hypersurface Ω (with boundary) in a (3+1)-spacetime (M,g) that satisfies the dominant energy condition, where g is the restriction of the space-time metric g to Ω .

One wishes to assign a notion of mass to (Ω, g) ; in fact ideally, [Bar97], the notion of mass should depend just on the restriction of g to $\partial\Omega$, the second fundamental form of $\Omega \subset M$ at $\partial\Omega$, as well as the second fundamental form of $\partial\Omega$ inside Ω .

Bartnik's definition, see [Bar97, Cor17], considers such data on $\partial\Omega$ and associates to it a class \mathcal{PM} of admissible asymptotically flat extensions (M_{ext},g_{ext}) , and seeks to minimize the ADM mass among all such extensions. There are many possibilities on how to define the space \mathcal{PM} of extensions, see [Bar97]. The most "minimal" requirements are that the 3-metrics $g_{ext} \in \mathcal{PM}$ should be of nonnegative scalar curvature, the metrics on ∂M_{ext} induced from the two sides Ω (interior side) and M_{ext} (exterior side) should match: $g_{ext}|_{\partial M_{ext}} = g|_{\partial\Omega}$; moreover, the mean curvature H_{ext} of ∂M_{ext} in M_{ext} should agree with the mean curvature H_{int} of $\partial M_{ext} = \partial\Omega$ with respect to the interior metric g over Ω . Additional requirements, such as the non-existence of closed minimal surfaces in the extension (M_{ext},g_{ext}) are very natural (see [Bar97]) and are also frequently imposed. Once the class of admissible extensions has been chosen the Bartnik Mass is defined to be the infimum of the ADM masses, among all admissible extensions.

An important feature of the Bartnik mass is the result of Corvino and Anderson-Jauregui, [Coroo, Cor17, AJ19] that if this infimum is attained for some (asymptotically flat) metric \mathfrak{g} , on a manifold M_{ext} with $\partial M_{ext} = \partial \Omega$, then this extension \mathfrak{g} must satisfy the system of equations:

$$\Delta_{\mathfrak{g}}f = 0$$
, $\operatorname{Ric}_{\mathfrak{g}} = f^{-1}\operatorname{Hess}_{\mathfrak{g}}(f)$, (1.1)

as well as the two imposed requirements

$$\mathfrak{g}|_{\partial M_{\rm ext}} = g|_{\partial \Omega}, \quad H_{\rm ext}(\mathfrak{g}) = H_{\rm int}.$$
 (1.2)

A solution to the system (1.1) implies that the metric $\mathbf{g} = -f^2 dt^2 + \mathfrak{g}$ on $M_{ext} \times \mathbb{R}$ would satisfy the Einstein Vacuum equations, and also be static, in the sense that $\mathcal{L}_{\partial_t} \mathbf{g} = 0$.

Remark 1.1. We note further that if the Bartnik minimizer exists, it is known–see [Bar97]–that the metric g_{total} defined over $M_{total} = \Omega \cup M_{ext}$ by joining g with $\mathfrak g$ across ∂M_{ext} is generically expected to be merely Lipschitz across the joining boundary ∂M_{ext} : The traceless parts $\hat{K}|_{g}$, $\hat{K}|_{\mathfrak g}$ of the second fundamental forms $K|_{g}$, $K|_{\mathfrak g}$ induced on $\partial \Omega = \partial M_{ext}$ from the two sides (Ω, g) , $(M_{ext}, \mathfrak g)$ are generically expected to not match.

Remark 1.2. In this thesis, we define the mean curvature of a surface in a 3-manifold as half the trace of the second fundamental form of the surface. In particular, the mean curvature of the round unit sphere in \mathbb{R}^3 is 1.

In view of the result of [Coroo] the question of the attainment of the Bartnik mass leads to the Bartnik static extension problem with data supported on a 2-sphere:

Question (Bartnik static metric extension problem). Consider a C^2 Riemannian 2-sphere (S^2, γ) equipped with a C^1 function H over S^2 . We consider a (topological) manifold $M = \mathbb{R}^3 \setminus B$ and seek a C^2 asymptotically flat metric \mathfrak{g} over M which satisfies:

- $\mathfrak{g}|_{\partial M} = \gamma$,
- the mean curvature H_{ext} of ∂M relative to \mathfrak{g} equals H, and:
- There exists a C^2 positive function f over M with $f(x) \to 1$ as $|x| \to \infty$ on M so that the pair (\mathfrak{g}, f) satisfy the system of equations (1.1).

Definition 1. The system in (1.1) will be called the *static vacuum equations*. The pair of prescribed data over S^2 (the metric γ and the putative mean curvature function H) will be called *Bartnik data*. A solution (\mathfrak{g} , f) to (1.1) to this prescribed data with \mathfrak{g} being asymptotically flat and f going to 1 at infinity will be called a *static vacuum extension* with Bartnik data (γ , H).

Two important examples of static vacuum extensions are:

- 1. The Euclidean solution $(g_{euc}, 1)$ on $\mathbb{R}^3 \setminus B_1$ with Bartnik data $(\gamma_{\mathbb{S}^2}, 1)$, where $\gamma_{\mathbb{S}^2}$ is the round metric on S^2 .
- 2. The Riemannian Schwarzschild solution $(\mathfrak{g}_{sc}, f_{sc})$ with mass m_0 on $\mathbb{R}^3 \setminus B_{r_0}$ and Bartnik data $(r_0^2 \gamma_{\mathbb{S}^2}, \frac{f_{sc}(r_0)}{r_0})$, where $r_0 > 2m_0$ and

$$\mathfrak{g}_{sc} = f_{sc}^{-2} dr^2 + r^2 \gamma_{S^2}, \qquad f_{sc} = \sqrt{1 - \frac{2m_0}{r}}$$

Since the static vacuum equations are highly nonlinear, one first hopes to achieve a local well-posedness result near arbitrary solutions. In fact, Anderson and Khuri in [AKo9] prove, by means of counterexamples, that global well-posedness does not hold (see also [And23]) . Nonetheless, there has been significant progress on establishing local well-posedness results. Miao in [Miao3] confirmed that the extension problem is locally well-posed near Euclidean Bartnik data on the unit sphere under a triple reflectional symmetry assumption. This symmetry assumption was later removed by Anderson in [And15] with the result generalized by Huang and An in [AH21] and [AH22a] for a large range of connected embedded surfaces in Euclidean \mathbb{R}^3 .

Subsequently, Huang and An in [AH22b] introduced a general criterion for local well-posedness near a given solution, which hinges on the triviality of the kernel of a particular operator. They identified a class of static vacuum extensions they call "static regular", characterized by the linearized operator having a trivial kernel, as sufficient conditions for local well-posedness. They showed that static regularity is, in some sense, generic for smooth hyper surfaces which are already inside a static vacuum extension. However since this relies in a very essential way on the data already lying in the interior of a given solution (which must be analytic), this result does not guarantee genericity in any sense in the space of smooth Bartnik data. Their findings in particular implies that for any given $m_0 > 0$ and $\epsilon > 0$, the set of radii $r_0 \ge 2m_0 + \epsilon$ for which the Schwarzschild manifold $\mathbb{R}^3 \setminus B_{r_0}$ with mass m_0 is static regular forms an open dense subset of $[2m_0 + \epsilon, \infty)$.

Summary of Main Results

Our main result in this paper is establishing local well-posedness for perturbations of *e*very Schwarzschild solution, hence strengthening Huang and An's result in [AH22b]. We present a new approach to this problem that can be applied to similar extension problems. In this approach, we write the putative solution (\mathfrak{g}, f) with respect to a geodesic gauge, which was not used before for this problem. One benefit of this gauge is that the connection coefficients of the desired solution \mathfrak{g} can be linked to f by *ordinary* differential equations, where f provides the forcing terms. More precisely, we will be considering the metrics $g := f^2 \cdot \mathfrak{g}$, whose Ricci curvature must then satisfy: $Ric_{ij}(g) = 2\nabla_i u \otimes \nabla_j u$ (with $u = \ln f$), and we will reduce the extension problem in (1.1) to an elliptic equation on u coupled with Riccatti equations on the second fundamental form of g, with

u providing the forcing term, and constraint equations on the boundary coming from the contracted Gauss and Codazzi equations. We rigorously establish estimates for the linearized operator and its inverse, showing that the linearization of the reduced equations is an isomorphism on appropriate Banach spaces. We then invoke the implicit function theorem on Banach manifolds to conclude local well-posedness.

An interesting remark concerns the expected difficulty of solving Bartnik's extension problem when the Schwarzschild sphere is very close to the horizon, in which the mean curvature is positive but very small. This difficulty is anticipated by the black hole uniqueness theorem (see [Isr67]), which in particular implies the following: for surfaces with zero mean curvature, the existence of static vacuum extensions fails unless the surface is a round sphere, in which case the Schwarzschild exteriors are the only possible extension. Therefore, one expects that the space of allowed perturbations of the Schwarzschild spheres S_r must be shrinking as r goes to $2m_0$. This also suggests that solving the linearized problem should be progressively harder as $r \to 2m_0$. We do capture this difficulty in our analysis and resolve it (see proposition 5.20), showing the solvability of Barntik's extension problem near all spheres S_r , $r > 2m_0$.

The choice of gauge influences which Banach spaces are most appropriate to use. Due to our choice of gauge, the equations in (1.1) reduce to an elliptic PDE coupled with transport equations. Consequently, the standard spaces used for elliptic PDEs, such as weighted Sobolev and Hölder spaces, are not appropriate as they do not provide the correct setting to solve transport equations. Instead, we use spaces of Bochner-measurable functions that are traditionally used as the setting to study hyperbolic and parabolic PDEs (see [Eva98]). More specifically, the spaces we use for u are $\mathcal{A}_{C_{\delta}}^{(2,k)}(M)$ and $\mathcal{A}_{H_{\delta}}^{(2,k)}(M)$ defined by (see definition 2.9)

$$u \in \mathcal{A}_{H_{\delta}}^{(2,k)}(M) \iff \begin{cases} u \in L_{\delta}^{2}\left([r_{0},\infty);H^{k}(S^{2})\right) \\ \partial_{r}u \in L_{\delta-1}^{2}\left([r_{0},\infty);H^{k-1}(S^{2})\right) \\ \partial_{r}^{2}u \in L_{\delta-2}^{2}\left([r_{0},\infty);H^{k-2}(S^{2})\right) \end{cases}$$

$$u \in \mathcal{A}_{C_{\delta}^{(2,k)}}(M) \iff \begin{cases} u \in C_{\delta}^{0}\left([r_{0},\infty);H^{k}(S^{2})\right) \\ \partial_{r}u \in C_{\delta-1}^{0}\left([r_{0},\infty);H^{k-1}(S^{2})\right) \\ \partial_{r}^{2}u \in C_{\delta-2}^{0}\left([r_{0},\infty);H^{k-2}(S^{2})\right) \end{cases}$$

where $r_0 > 0$, $k \ge 2$, and $\delta \in (-1, -\frac{1}{2})$ is a weight introduced appropriately in the norms of the above spaces to control the decay at infinity. These spaces are not traditionally used to study elliptic PDEs. In this paper, we establish solvability of a certain elliptic problem in the above spaces. More specifically, defining the operator $Q: u \mapsto (\Delta_g u, u|_{\partial M})$ with respect to a certain asymptotically flat metric g on $M = \mathbb{R}^3 \setminus B_{r_0}$, we demonstrate that (see chapter 3)

$$Q: \mathcal{A}_{H^{(2,k)}_{\delta}}(M) \to L^2_{\delta-2}\left([r_0,\infty); H^{k-2}(S^2)\right) \times H^{k-1/2}(\partial M) \qquad \text{is an isomorphism}$$

$$Q: \mathcal{A}_{C^{(2,k)}_{\delta}}(M) \to C^0_{\delta-2}\left([r_0,\infty); H^{k-2}(S^2)\right) \times H^k(\partial M) \qquad \text{is an isomorphism}$$

This result can be generalized to arbitrary asymptotically flat metrics and more general elliptic boundary value problems, thereby establishing the solvability of such problems in the above spaces.

An interesting comparison we can make to the above is the study of elliptic boundary value problems in C^k spaces. It is well known that there is no general existence theorem for elliptic boundary value problems in $C^k(M)$ (see [GT13] problem 4.9 for a counterexample). In [GT13], the authors demonstrate via the celebrated Schauder and Calderon-Zygmund estimates that Hölder spaces $C^{k,\alpha}(\Omega)$ and Sobolev spaces $H^k(\Omega)$ on a bounded open set Ω , instead of $C^k(\Omega)$, have sufficiently nice properties allowing for general existence theorems for elliptic boundary value problems. Modification of those spaces by including weights generalizes these existence results to unbounded spaces (see for example [Bar86]). In this paper, we establish an existence theorem in $C^0_\delta\left([r_0,\infty);H^k(S^2)\right)$ spaces, a mix of both Hölder and Sobolev spaces. Our work readily implies similar existence results in the spaces $C^0([a,b]:H^k(S^2))$ when the domain is bounded.

Let $M := \mathbb{R}^3 \setminus B_{n \cdot m_0}$ where n > 2 and $m_0 > 0$. Denote by g_{euc} the Euclidean metric on M and by $\gamma_{\mathbb{S}^2}$ the round metric on the unit sphere S^2 .

2.1 PROPERTIES OF STATIC VACUUM EXTENSIONS

In this section, we will discuss some decay and regularity properties of static vacuum extensions and demonstrate that they can be written in the geodesic gauge. More precisely, we will show that given a static vacuum extension (\mathfrak{g}, f) , we can globally write the metric $g := f^{-2}\mathfrak{g}$ in geodesic coordinates so that \mathfrak{g} takes the form

$$\mathfrak{g} = f^{-2}dr^2 + \gamma_{\mathfrak{g}_r}$$

where r is the distance function from the boundary with respect to g and $\gamma_{\mathfrak{g}_r}$ is the induced metric on the level sets of r. Note that this form is directly observable in the Schwarzschild solutions $(\mathfrak{g}_{\mathfrak{sc}}, f_{\mathfrak{sc}})$ as $\mathfrak{g}_{\mathfrak{sc}}$ is given by

$$\mathfrak{g}_{\mathfrak{sc}} = f_{sc}^{-2} dr^2 + r^2 \gamma_{\mathbb{S}^2}$$

Definition 2.1. Let $\eta > 0$. A \mathcal{C}^2 metric \mathfrak{g} over M is asymptotically flat of order $\eta > 0$ if there exists a coordinate system (x^1, x^2, x^3) near infinity in which the metric satisfies

- $\mathfrak{g}_{ij} \delta_{ij} = \mathcal{O}(|x|^{-\eta})$
- $\partial_k \mathfrak{g}_{ij} = \mathcal{O}(|x|^{-\eta-1})$
- $\partial_l \partial_k \mathfrak{g}_{ij} = \mathcal{O}(|x|^{-\eta-2})$

where $\partial_k := \frac{\partial}{\partial x^k}$ and $|x| = \sqrt{|x^1|^2 + |x^2|^2 + |x^3|^2}$. For conciseness, we will write $\mathfrak{g}_{ij} = \delta_{ij} + \mathcal{O}_2(|x|^{-\eta})$ if the above conditions are satisfied.

Definition 2.2. For a metric \mathfrak{g} and a positive function f, we say that a pair (\mathfrak{g}, f) is a strongly asymptotically flat if \mathfrak{g} admits a coordinate system (x^1, x^2, x^3) near infinity in which

$$g_{ij} = \left(1 + \frac{2m}{|x|}\right)\delta_{ij} + \mathcal{O}_2(|x|^{-2}), \qquad f = 1 - \frac{m}{|x|} + \mathcal{O}_2(|x|^{-2})$$
 (2.1)

The Schwarzschild solutions ($\mathfrak{g}_{\mathfrak{sc}}$, f_{sc}) discussed in the introduction are examples of smooth strongly asymptotically flat static vacuum extensions.

The system in (1.1) is equivalent to a lower order system of equations. Letting $g := f^2 \mathfrak{g}$, $u := \ln u$, a direct computation shows that (\mathfrak{g}, f) solves equation (1.1) if and only if (g, u) solve

$$Ric_{\varphi} = 2du \otimes du, \qquad \Delta_{\varphi}u = 0.$$
 (2.2)

We will call the above equations the conformal static vacuum equations. We will call the pair $(g_{sc}, u_{sc}) := (f_{sc}^2 \mathfrak{g}_{sc}, \ln f_{sc})$ the conformal Schwarzchild solution.

By taking advantage of the form that the Ricci curvature takes for g, Murchadha in [KM95] shows that every static vacuum extension (\mathfrak{g}, f) is strongly asymptotically flat and is smooth away from the boundary. For the rest of this section, we will describe how this strong decay and regularity of static vacuum extensions allows us to write the extension problem in a geodesic gauge.

Let (g, u) solve the conformal static vacuum equations in (2.2). We wish to write the metric g in geodesic coordinates. Let $r(\cdot) = \operatorname{dist}(\cdot, \partial M) + r_0$ be a shifted distance function from ∂M . Due to the compactness of ∂M , the function r is smooth on a neighborhood of ∂M , with ∂M excluded, and so defines a foliation near ∂M with the leaves being the level sets of r. We can then write the metric with respect to this foliation as $dr^2 + \gamma_r$ where γ_r is the induced metric on the level sets. This representation of the metric generally does not hold globally and is valid only whenever r is differentiable. However, if g is close enough to g_{sc} in a weighted \mathcal{C}^2 norm, it will hold that r is differentiable everywhere on $M \setminus \partial M$ and the metric can be written globally as $dr^2 + \gamma_r$. This follows from the next proposition, which follows from a straightforward adaptation of the argument in proposition 5.0.1 in [CK93].

Proposition 2.3. There exists $\tau' = \tau'(n, m_0) > 0$ small enough such that the following is true for any $0 < \tau < \tau'$.

If an asymptotically flat metric g on M of order $\eta>0$ satisfies in Cartesian coordinates

$$|x|^{\eta}|g - g_{sc}| + |x|^{\eta+1}|\partial g - \partial g_{sc}| + |x|^{\eta+2}|\partial \partial g - \partial \partial g_{sc}| < \tau$$
 (2.3)

where $|\cdot|$ *is with respect to the Euclidean metric* δ *, then:*

1. The affine parameter $r(\cdot) = dist_g(\partial M, \cdot) + nm_0$ is differentiable everywhere on $M \setminus \partial M$ and defines a global radial foliation with leaves S_r diffeomorphic to S^2 . Moreover, given a coordinate system (x^1, x^2, x^3) near infinity as described in definition 2.1, r and |x| are comparable in the sense that

$$C^{-1}|x| \le r \le C|x| \tag{2.4}$$

for some constant C > 0.

2. With respect to this foliation, we have

$$trK = \frac{2}{r} + \mathcal{O}_1(r^{-1-\eta}), \qquad |\hat{K}| = \mathcal{O}_1(r^{-1-\eta})$$
 (2.5)

where K = Hess(r) is the second fundamental form on the leaves S_r , trK is the trace of K, and \hat{K} is the traceless part of K.

3. There exists a unique diffeomorphism $\Phi: M \to [nm_0, \infty) \times S^2$ such that $\Phi|_{\partial M} = Id_{S^2}$, $r(\cdot) = \pi_r \circ \Phi(\cdot)$ where π_r is the projection onto the first coordinate, and $\Phi_*g = dr^2 + \gamma_{g_r}$ where γ_{g_r} is the push forward of the induced metric on S_r .

Proof. We give a sketch of the proof, which is an adaptation of the proof of proposition 5.0.1 in [CK93].

Let g be an asymptotically flat metric on M of order $\eta > 0$. Let e_A , A = 1, 2, be an orthonormal frame tangential to the leaves S_r of the foliation defined by $r(\cdot) := \operatorname{dist}_g(\partial M, \cdot) + nm_0$. Since ∂M is compact, the foliation defined by r exists on a neighbourhood of ∂M .

The geometry equations with respect to this foliation take the following from (see equations 5.0.5a-5.0.5b in [CK93]):

$$\frac{\partial}{\partial r}trK = -\frac{1}{2}(trK)^2 - |\hat{K}|^2 - R_{nn}$$
(2.6)

$$\frac{\partial}{\partial r}\hat{K}_{AB} = -(trK)\hat{K}_{AB} - \hat{R}_{AB} \tag{2.7}$$

where *n* is the unit normal vector field on S_r and $\hat{R}_{AB} = R_{AB} - \frac{1}{2}(R - R_{nn})g_{AB}$ for A, B = 1, 2.

Letting $h := \frac{2}{trK}$, it follows that h and $|\hat{K}|$ satisfy

$$\frac{\partial}{\partial r}h = 1 + \frac{1}{2}h^2(|\hat{K}|^2 + R_{nn}) \tag{2.8}$$

$$\frac{\partial}{\partial r}|\hat{K}| + 2h^{-1}|\hat{K}| \le |\hat{R}| \tag{2.9}$$

Assuming the smallness condition in equation (2.3), standard comparison arguments then imply the desired estimates for r, trK and \hat{K} (see proof of proposition 5.0.1 in [CK93]). In particular, the above ODEs are solvable on the domain $[nm_0, \infty)$ implying that the level sets of r provide a global foliation of M.

This allows us to globally express a static vacuum extension (\mathfrak{g}, f) that is close to $(\mathfrak{g}_{\mathfrak{sc}}, f_{sc})$ in the sense of equation (2.3) in geodesic coordinates as follows:

$$g = f^{-2}dr^2 + \gamma_{g_r}$$
, where γ_{g_r} is the induced metric on S_r

and, hence, justifies the space of metrics that we will be working in (see definition 2.8 in the next section).

2.2 FUNCTION SPACES

In this section, we define the function spaces that we will be using. Fix $k \in \mathbb{Z}_{\geq 0}$ and $\delta \in \mathbb{R}$. From here onwards, we will identify M with the space $[nm_0, \infty) \times S^2$.

Definition 2.4. We define the weighted Sobolev space $H^k_{\delta}(M)$ with weight δ to be the space of all functions u in $H^k_{loc}(M)$ such that $\|u\|_{k,\delta} < \infty$ respectively, where

$$||u||_{k,\delta} = \sum_{l=0}^{k} \left\{ \int_{M} \left(|D^{l}u| \cdot r^{l-\delta} \right)^{2} r^{-3} dV \right\}^{\frac{1}{2}}$$
 (2.10)

where r = |x|, D is the connection with respect to the Euclidean metric on M, and dV is the Euclidean volume form on M. We will also denote the space $H^k_\delta(M)$ by $L^2_\delta(M)$ when k = 0.

Definition 2.5. We define the space $\mathcal{X}_{\delta}^k(M)$ to be the space of vector fields X on M with components $X^i := X(x^i)$ in $H_{\delta}^k(M)$, where (x^1, x^2, x^3) is the standard cartesian coordinates. The norm we use is

$$||X||_{k,\delta} := \sum_{l=0}^{k} ||D^{l}X||_{0,\delta-l}$$
 (2.11)

Definition 2.6. Let $H^k(S^2)$ be the usual L^2 space, when k = 0, and Sobolov space, when $k \geq 1$, on (S^2, γ_{S^2}) . Let $\mathcal{M}^k(S^2)$ and $\mathcal{H}^k(S^2)$ be the space of metrics on S^2 and symmetric tensors on S^2 , respectively, with components in $H^k(S^2)$ with respect to a spherical coordinate system. The norm we will use is as follows:

$$||h||_{\mathcal{H}^k(S^2)}^2 := \sum_{l=0}^k ||D^l h||_{L^2(S^2)}^2$$
 (2.12)

where \mathcal{D} is the covariant derivative on S^2 with respect γ_{S^2} .

Let $\Omega^k(S^2)$ be the space of 1-forms on S^2 with components in $H^k(S^2)$. The norm used on this space is as follows:

$$\|\omega\|_{\Omega^{k}(S^{2})}^{2} := \sum_{l=0}^{k} \||\mathcal{D}^{l}\omega|\|_{L^{2}(S^{2})}^{2}$$
 (2.13)

Definition 2.7. Let $t \in \mathbb{Z}_{\geq 0}$. We define the space $H^t_{\delta}\left([nm_0,\infty);H^k(S^2)\right)$ to be the space of functions u in $H^t_{loc}\left([nm_0,\infty);H^k(S^2)\right)$ such that $\|u\|_{H,(t\to k),\delta} < \infty$, where

$$||u||_{H,(t\to k),\delta}^2 := \sum_{t'=0}^t \int_{nm_0}^\infty r^{-2\delta - 1 + 2t'} \left\| \partial_r^{(t')} u(r) \right\|_{H^k(S^2)}^2 dr \qquad (2.14)$$

We also define the space $C^t_\delta\left([nm_0,\infty);H^k(S^2)\right)$ to be the space of continuous $H^k(S^2)$ -valued functions u on $[nm_0,\infty)$ such that $\|u\|_{C,(t\to k),\delta}<\infty$, where

$$||u||_{C,(t\to k),\delta}^2 := \sum_{t'=0}^t \sup_{r\geq nm_0} \left(r^{-2\delta+2t'} \left\| \partial_r^{(t')} u(r) \right\|_{H^k(S^2)}^2 \right) \tag{2.15}$$

We then define the space $H^t_{\delta}\left([nm_0,\infty);\mathcal{M}^k(S^2)\right)$ and $H^t_{\delta}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$ similarly to the above with norm

$$||h||_{H,(t\to k),\delta}^2 := \sum_{t'=0}^t \int_{nm_0}^\infty r^{-2\delta - 1 + 2t'} \left\| \partial_r^{(t')} h(r) \right\|_{\mathcal{H}^k(S^2)}^2 dr \tag{2.16}$$

Definition 2.8. Define $\mathcal{M}_{\delta}^k(M)$ to be the space of metrics on $[nm_0,\infty)\times S^2$ of the form $dr^2+g(r)$ where $g(r)=r^2(\gamma_\infty+h(r)), \gamma_\infty\in\mathcal{M}^k(S^2)$, and $h\in H^2_{\delta}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$. The space $\mathcal{M}_{\delta}^k(M)$ can be naturally identified with an open subset of the Banach space $\mathcal{H}^k(S^2)\oplus H^2_{\delta}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$. This makes $\mathcal{M}_{\delta}^k(M)$ an open Banach submanifold of $\mathcal{H}^k(S^2)\oplus H^2_{\delta}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$ and, in particular, a Banach manifold. Given $g_0\in\mathcal{M}_{\delta}^k(M)$, the tangent space $T_{g_0}M_{\delta}^k$ is isomorphic to the space of tensors \tilde{g} of the form $\tilde{g}=r^2(\tilde{\gamma}_\infty+\tilde{h}(r))$, where $\tilde{\gamma}_\infty\in\mathcal{H}^k(S^2)$ and $\tilde{h}\in H^2_{\delta}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$, equipped with the norm

$$\|\tilde{g}\|_{\mathcal{M}^k_{\delta}} := \|\tilde{\gamma}_{\infty}\|_{\mathcal{H}^k(S^2)} + \|\tilde{h}\|_{H,(2\to k),\delta} \tag{2.17}$$

Definition 2.9. Let $t \geq 0$. Denote by $\mathcal{A}_{H_{\delta}}^{(t,k)}(M)$ and $\mathcal{A}_{C_{\delta}}^{(t,k)}(M)$ the spaces

$$\mathcal{A}_{H_{\delta}^{(t,k)}}(M) := \bigcap_{t'=0}^{t} H_{\delta}^{t'}\left([nm_{0},\infty); H^{k-t'}(S^{2})\right), \qquad \mathcal{A}_{C_{\delta}^{(t,k)}}(M) := \bigcap_{t'=0}^{t} C_{\delta}^{t'}\left([nm_{0},\infty); H^{k-t'}(S^{2})\right)$$
(2.18)

equipped with the norms

$$\|u\|_{\mathcal{A}_{H_{\delta}}^{(t,k)}}^{2} := \max_{0 \le t' \le t} \|u\|_{H,(t' \to k - t'),\delta}^{2}, \qquad \|u\|_{\mathcal{A}_{C_{\delta}}^{(t,k)}}^{2} := \max_{0 \le t' \le t} \|u\|_{C,(t' \to k - t'),\delta}^{2}$$
(2.10)

Note that

$$u \in \mathcal{A}_{H_{\delta}^{(t,k)}}(M) \iff \text{for every } 0 \leq t' \leq t, \ \partial_r^{(t')} u \in L^2_{\delta-t'}\left([nm_0,\infty); H^{k-t'}(S^2)\right)$$

$$u \in \mathcal{A}_{C_{\delta}}^{(t,k)}(M) \iff \text{for every } 0 \le t' \le t, \ \partial_r^{(t')} u \in C_{\delta-t'}^0\left([nm_0,\infty); H^{k-t'}(S^2)\right)$$

Denote the intersection of these spaces by $\mathcal{A}^{(t,k)}_{\delta}(M)$ defined by

$$\mathcal{A}_{\delta}^{(t,k)}(M) := \mathcal{A}_{H_{\delta}}^{(t,k)}(M) \cap \mathcal{A}_{C_{\delta}}^{(t,k)}(M)$$

equipped with the norm

$$\|u\|_{\mathcal{A}_{\delta}^{(t,k)}}^{2} := \max_{0 \le t' \le t} (\|u\|_{H,(t' \to k - t'),\delta}^{2} + \|u\|_{C,(t' \to k - t'),\delta}^{2})$$
(2.20)

In the next proposition, we list some important results regarding the spaces we defined that will be repeatedly used in the rest of the paper.

Proposition 2.10.

(a) Let $k \geq 0$, $t \geq 1$ and $\delta < 0$. Every function $u \in H^t_{\delta}([nm_0, \infty); H^k(S^2))$ has a representative in $C^{t-1}_{loc}([nm_0, \infty); H^k(S^2))$, which will also be denoted by u. Furthermore, there exists a constant C > 0 such that for every $u \in H^t_{\delta}([nm_0, \infty); H^k(S^2))$

$$||u||_{C,(t-1\to k),\delta} \le C ||u||_{H,(t\to k),\delta}$$
 (2.21)

If in addition $k \geq 2$, then $\partial_r^{(t')}u(r) \in C^{k-2}(S^2)$ for every $r \in [nm_0, \infty)$ and $0 \leq t' \leq t-1$. Also, for every $0 \leq l \leq k-2$ and $0 \leq t' \leq t-1$,

$$|\mathcal{D}^l \partial_r^{(t')} u| = o(r^{\delta - l - t'}) \quad \text{as } r \to \infty$$
 (2.22)

(b) Let $dr^2 + g(r) \in \mathcal{M}^k_{\delta}(M)$ with $g(r) = r^2(\gamma_{\infty} + h(r))$.

Then with respect to the foliation defined by the level sets of r, the trace and traceless part of the second fundamental form satisfy

$$\left| trK - \frac{2}{r} \right| \in H^1_{\delta-1} \left([nm_0, \infty); H^k(S^2) \right), \qquad \hat{K} \in H^1_{\delta-1} \left([nm_0, \infty); \mathcal{H}^k(S^2) \right)$$
(2.23)

Furthermore, the metric $dr^2 + g(r)$ is asymptotically flat if and only if γ_{∞} is of constant curvature 1.

- (c) Let $k_1 < k_2$, $t_1 < t_2$, and $\delta_2 < \delta_1 < 0$. Then the space $H^{t_2}_{\delta_2}\left([nm_0,\infty); H^{k_2}(S^2)\right)$ is compactly embedded in $H^{t_1}_{\delta_1}\left([nm_0,\infty); H^{k_1}(S^2)\right)$. Furthermore, the space $C^{t_2}_{\delta_2}\left([nm_0,\infty); H^{k_2}(S^2)\right)$ is compactly embedded in $C^{t_1}_{\delta_1}\left([nm_0,\infty); H^{k_1}(S^2)\right)$.
- (d) Let $k \geq 1$ and $\delta \in \mathbb{R}$. Suppose a function u satisfies

$$u \in L^2_\delta\left([nm_0,\infty);H^k(S^2)\right)(M), \quad \partial_r u \in L^2_{\delta-1}\left([nm_0,\infty);H^{k-1}(S^2)\right)(M)$$

Then for every $r \in [nm_0, \infty)$,

$$u(r) \in H^{k-1/2}(S^2)$$

Proof. (a), (b) and (d) follow immediately from standard results on Sobolev spaces (see [Bar86] theorem 1.2 and lemma 1.4, and [Eva98] section 5.9).

We focus on proving (b). The metric g(r) evolves according to the equation

$$\partial_r g(r) = tr K g(r) + 2\hat{K} \tag{2.24}$$

where $K = \operatorname{Hess}(r)$ is the second fundamental form on the leaves S_r , trK is the trace of K, and \hat{K} is the traceless part of K. Since $g(r) = r^2(\gamma_\infty + h(r))$, it follows that

$$trK = \frac{2}{r} + \frac{1}{2}tr_{r^{-2}g(r)}(\partial_r h(r)), \quad 2\hat{K} = r^2 \Big(\partial_r h(r) - tr_{g(r)}(\partial_r h(r))g(r)\Big)$$
(2.25)

This directly implies equation (2.23)

In view of the twice contracted Gauss equation and the Riccati equation, we get

$$R = 2Ric(\frac{\partial}{\partial r}, \frac{\partial}{\partial r}) + R_{S_r} - \frac{1}{2}(trK)^2 + |\hat{K}|^2, \qquad Ric(\frac{\partial}{\partial r}, \frac{\partial}{\partial r}) = -\partial_r trK - \frac{1}{2}(trK)^2 - |\hat{K}|^2$$
(2.26)

It follows immediately using equation (2.23) and the fact that the scalar curvature $R_{\gamma_{\infty}}$ of (S^2, γ_{∞}) is the limit of $r^2R_{S_r}$ as r goes to infinity that R decays faster than r^{-2} if and only if $R_{\gamma_{\infty}} = 2$. We conclude that the metric is asymptotically flat if and only if γ_{∞} is of constant curvature 1.

2.3 THE MAIN THEOREM

Definition 2.11. In place of the mean curvature H, we will work with $trK_{\mathfrak{B}} := 2H$ for convenience, which represents the trace of the hypothetical second fundamental form on ∂M . From this point forward, we will denote the Bartnik data on ∂M by $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})$. We will also denote by $(\gamma_{\mathfrak{gsc}}, \frac{1}{2}trK_{\mathfrak{gsc}})$ the Schwarzschild Bartnik data, which is given by

$$\gamma_{\mathfrak{g}_{\mathfrak{sc}}} = (nm_0)^2 \gamma_{\mathbb{S}^2}, \quad tr K_{\mathfrak{g}_{\mathfrak{sc}}} = \frac{2\sqrt{1 - \frac{2}{n}}}{nm_0}$$
(2.27)

The statement of the main theorem is as follows.

Main Theorem. Let $M := \mathbb{R}^3 \setminus B_{nm_0}$ where $m_0 > 0$ and n > 2. Let $\delta \in (-1, -\frac{1}{2}]$ and $k \geq 5$. There exists a neighbourhood \mathcal{U} of $(\gamma_{\mathfrak{g}_{\mathfrak{g}_{\mathfrak{c}}}}, \frac{1}{2}trK_{\mathfrak{g}_{\mathfrak{g}_{\mathfrak{c}}}})$ in

 $\mathcal{M}^{k+1}(\partial M) \times H^k(\partial M)$ and a unique \mathcal{C}^1 map $\mathbf{H}: (\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}}) \mapsto (g, u)$ on \mathcal{U} to $\mathcal{M}^k_{\delta}(M) \times \mathcal{A}^{(2,k+1)}_{\delta}(M)$ in which $(\mathfrak{g}, f) := (e^{-2u}g, e^u)$ solves the static Einstein vacuum equations with Bartnik data $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})$.

Given Bartnik data $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}}) \in \mathcal{U}$, the pair $(g, u) = \mathbf{H}(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})$ will then solve the conformal static vacuum equations written out in equation (2.2). Due to proposition 2.10, \mathfrak{g} and f are \mathcal{C}^2 on M and satisfy, in some coordinates (x^1, x^2, x^3) ,

$$g_{ij} = \delta_{ij} + \mathcal{O}_2(|x|^{\delta}), \quad f = 1 + \mathcal{O}_2(|x|^{\delta})$$
 (2.28)

Moreover, the discussion in section 2.1 implies that (\mathfrak{g}, f) is strongly asymptotically flat and is smooth away from the boundary.

SOLVABILITY OF ELLIPTIC BVP IN $\mathcal{A}_{H_{\delta}}^{(2,k)}(M)$ AND $\mathcal{A}_{C_{\delta}}^{(2,k)}(M)$

In this chapter, we will establish the well-posedness of the elliptic PDE $\Delta_{g_{sc}}\tilde{u}=0$ on (M,g_{sc}) , subject to Dirichlet boundary conditions, in the function spaces $\mathcal{A}_{H_{\delta}}^{(2,k)}(M)$ and $\mathcal{A}_{C_{\delta}}^{(2,k)}(M)$. Here, g_{sc} is the conformal Schwarzschild metric on $M=\mathbb{R}^3\setminus B_{n\cdot m_0}$ given by

$$g_{sc} = dr^2 + r(r - 2m_0)\gamma_{\mathbb{S}^2} \tag{3.1}$$

and n > 2, $m_0 > 0$.

More precisely, we will prove the following theorem.

Theorem 3.1. *Define the operator* Q *by:*

$$\mathcal{Q}(\tilde{u}) := egin{pmatrix} \Delta_{g_{sc}} \tilde{u} \ \tilde{u}|_{\partial M} \end{pmatrix}$$

For $\delta \in (-1, -\frac{1}{2}]$ and $k \ge 1$,

$$Q: \mathcal{A}_{H_{\delta}}^{(2,k+1)}(M) \to \mathcal{A}_{H_{\delta-2}}^{(0,k-1)}(M) \times H^{k+1/2}(\partial M)$$
 is an isomorphism

and

$$Q: \mathcal{A}_{C_{\delta}}^{(2,k+1)}(M) \to \mathcal{A}_{C_{\delta-2}}^{(0,k-1)}(M) \times H^{k+1}(\partial M)$$
 is an isomorphism

Remark 3.2. In particular, it holds that

$$Q: \mathcal{A}^{(2,k+1)}_{\delta}(M) o \mathcal{A}^{(0,k-1)}_{\delta-2}(M) imes H^{k+1}(\partial M)$$
 is an isomorphism,

which will be used in section 5.4.

The map Q can be defined on the space $\mathcal{A}_{H_{\delta}}^{(2,k+1)}(M)$ and $\mathcal{A}_{C_{\delta}}^{(2,k+1)}(M)$ with codomain $\mathcal{A}_{H_{\delta-2}}^{(0,k-1)}(M) \times H^{k+1/2}(\partial M)$ and $\mathcal{A}_{C_{\delta-2}}^{(0,k-1)}(M) \times H^{k+1}(\partial M)$

repsectively. Indeed, we deduce directly from the definition of our Banach spaces that for all $u \in \mathcal{A}_{H_{\delta}}^{(2,k+1)}(M)$,

$$\Delta_{g_{sc}}\tilde{u} = \partial_r^2 \tilde{u} + \frac{2(r - m_0)}{r(r - 2m_0)} \partial_r \tilde{u} + \frac{1}{r(r - 2m_0)} \Delta_{\gamma_{S^2}} \tilde{u}(r) \in L^2_{\delta - 2} \left([nm_0, \infty); H^{k-1}(S^2) \right) = \mathcal{A}_{H^{(0,k-1)}_{\delta - 2}}(M)$$

16

$$\tilde{u}(nm_0) \in H^{k+1/2}(S^2)$$
 (by proposition 2.10 (d))

Similarly, for all $u \in \mathcal{A}_{C_{\delta}}^{(2,k+1)}(M)$,

$$\Delta_{g_{sc}}\tilde{u} = \partial_r^2 \tilde{u} + \frac{2(r - m_0)}{r(r - 2m_0)} \partial_r \tilde{u} + \frac{1}{r(r - 2m_0)} \Delta_{\gamma_{\mathbb{S}^2}} \tilde{u}(r) \in C^0_{\delta - 2} \left([nm_0, \infty); H^{k-1}(S^2) \right) = \mathcal{A}_{C^{(0,k-1)}_{\delta - 2}}(M)$$

$$\tilde{u}(nm_0) \in H^{k+1}(S^2)$$

We recall the following result from Maxwell in [Maxo5]:

$$Q: H^2_{\delta}(M) \to L^2_{\delta-2}(M) \times H^{3/2}(\partial M)$$
 is an isomorphism

To prove theorem 3.1, it then suffices to prove the estimates

$$\|\tilde{u}\|_{\mathcal{A}_{H_{\delta}}^{(2,k+1)}} \leq C \|Q(\tilde{u})\|_{\mathcal{A}_{H_{\delta}-1}^{(0,k-1)} \times H^{k+1/2}(\partial M)}$$

$$\|\tilde{u}\|_{\mathcal{A}_{C_{\delta}}^{(2,k+1)}} \leq C \|Q(\tilde{u})\|_{\mathcal{A}_{C_{\delta-1}}^{(0,k-1)} \times H^{k+1}(\partial M)}$$

for all \tilde{u} in $\mathcal{A}_{H_{\delta}}^{(2,k+1)}(M)$ and $\mathcal{A}_{C_{\delta}}^{(2,k+1)}(M)$ respectively. These estimates will be the content of the next lemma.

Lemma 3.3. • There exist a constant C > 0 such that for any $\tilde{u} \in \mathcal{A}_{H_{\delta}}^{(2,k+1)}(M)$, the following estimate holds.

$$\|\tilde{u}\|_{\mathcal{A}_{H_{\delta}}^{(2,k+1)}} \le C\left(\|\Delta_{g_{sc}}\tilde{u}\|_{\mathcal{A}_{H_{\delta}}^{(0,k-1)}} + \|\tilde{u}\|_{H^{k+1/2}(\partial M)}\right) \tag{3.2}$$

• There exist a constant C > 0 such that for any $\tilde{u} \in \mathcal{A}_{C_{\delta}}^{(2,k+1)}(M)$, the following estimate holds.

$$\|\tilde{u}\|_{\mathcal{A}_{C_{\delta}}^{(2,k+1)}} \le C\left(\|\Delta_{g_{sc}}\tilde{u}\|_{\mathcal{A}_{C_{\delta}}^{(0,k-1)}} + \|\tilde{u}\|_{H^{k+1}(\partial M)}\right)$$
(3.3)

Proof. Since $\mathcal{A}^{(2,k+1)}_{\delta}(M)$ is dense in both $\mathcal{A}_{H^{(2,k+1)}_{\delta}}(M)$ and $\mathcal{A}_{C^{(2,k+1)}_{\delta}}(M)$, it suffices to prove both estimates for all $\tilde{u} \in \mathcal{A}^{(2,k+1)}_{\delta}(M)$.

Let $\tilde{u} \in \mathcal{A}_{\delta}^{(2,k+1)}$. Define $F := \Delta_{g_{sc}} \tilde{u}$ and $h := \tilde{u}(nm_0)$. Then

$$F \in \mathcal{A}^{(0,k-1)}_{\delta-2}(M) = L^2_{\delta-2}\left([nm_0,\infty);H^{k-1}(S^2)\right) \cap C^0_{\delta-2}\left([nm_0,\infty);H^{k-1}(S^2)\right), \quad h \in H^{k+1}(\partial M)$$

We utilize the spherical symmetry of (M, g_{sc}) to reduce the equation $\Delta_{g_{sc}}\tilde{u} = F$ to differential equations on the coefficients of \tilde{u} with respect to its spherical harmonics decomposition. Decompose \tilde{u}, F , and h as follows

$$\tilde{u}(r,x) = \sum_{\ell=0}^{\infty} \sum_{m=-\ell}^{\ell} a_{m\ell}(r) Y_{m\ell}(x), \quad F(r,x) = \sum_{\ell=0}^{\infty} \sum_{m=-\ell}^{\ell} b_{m\ell}(r) Y_{m\ell}(x), \quad h(x) = \sum_{\ell=0}^{\infty} \sum_{m=-\ell}^{\ell} c_{m\ell} Y_{m\ell}(x)$$
(3.4)

for $r \in [nm_0, \infty)$ and $x \in \partial M$. Here and below the spherical harmonics $Y_{m\ell}(x)$ are viewed as functions over the unit sphere S^2 . These same functions will also be thought of over round spheres of any other radius via the natural push-forward map. We will assume that they are normalized with respect to the round metric γ_{S^2} on the unit sphere.

We first rewrite the norms of the relevant Banach spaces in terms of the coefficients with respect to the spherical harmonics decomposition. For a nonnegative integer s and $f \in H^s(\partial M)$ with spherical harmonic coefficients $f_{m\ell}$, the norm

$$||f||_{H^{s}(\partial M)} := \left(\sum_{\ell=0}^{\infty} \sum_{m=-\ell}^{\ell} \left[1 + \ell(\ell+1)\right]^{s} |f_{m\ell}|^{2}\right)^{1/2}$$
(3.5)

is equivalent to the standard norm on $H^s(\partial M)$. For a nonnegative integer t and real number τ , we will rewrite the norm on $H^t_{\tau}\left([nm_0,\infty);H^s(S^2)\right)(M)$ and $C^t_{\tau}\left([nm_0,\infty);H^s(S^2)\right)$.

We begin with the norm on $H_{\tau}^t([nm_0,\infty);H^s(S^2))$ (M). Given a function $v \in H_{\tau}^t([nm_0,\infty);H^s(S^2))$, recall that

$$||v||_{H,(t\to s),\tau}^2 = \sum_{t'=0}^t \int_{nm_0}^\infty r^{-2\delta - 1 + 2t'} ||\partial_r^{t'} v(r)||_{H^s(S^2)}^2 dr$$

Let $v_{m\ell} = v_{m\ell}(r)$ be the spherical harmonic coefficients for v. The first term in the sum becomes

$$\int_{nm_0}^{\infty} r^{-2\delta - 1} \|v(r)\|_{H^s(S^2)}^2 dr = \sum_{\ell=0}^{\infty} \sum_{m=-\ell}^{\ell} \left[1 + \ell(\ell+1) \right]^s \int_{nm_0}^{\infty} r^{-2\delta - 1} |v_{m\ell}(r)|^2 dr$$

where we invoked the monotone convergence theorem to switch the order of the integral and the infinite sum. Now for each $1 \le t' \le t$ and $r \in [nm_0, \infty)$, we have that

In light of the fact that $v_{m\ell}(r)=\int_{S^2}Y_{m\ell}\ v(r)d\sigma_{S^2}$, it follows that $v_{m\ell}$ are differentiable t times in r and $v_{m\ell}^{(t')}$ are the spherical harmonic coefficients of $\partial_r^{t'}v$.

We can then rewrite the norm in equation (3.6) as follows:

It is then convenient to define the following norms for functions on $[nm_0, \infty)$: for a function $f_1 \in H^t_{loc}([nm_0, \infty))$ and $f_2 \in C^t([nm_0, \infty))$, define

We denote by $H^t_{\tau}([nm_0,\infty))$ and $C^t_{\tau}([nm_0,\infty))$ all functions $f_1 \in H^t_{loc}([nm_0,\infty))$ and $f_2 \in C^t([nm_0,\infty))$ in which $\|f_1\|_{H,t,\tau} < \infty$ and $\|f_2\|_{C,t,\tau} < \infty$ respectively.

Using the above notation, we can then write equation (3.6) and (3.11) as follows:

We now return to the statement of the lemma. Recall from equation (3.4) that

$$\begin{aligned} \left\| a_{m\ell}'' \right\|_{C,0,\delta-2}^2 + \left[1 + \ell(\ell+1) \right] \left\| a_{m\ell}' \right\|_{C,0,\delta-1}^2 + \left[1 + \ell(\ell+1) \right]^2 \left\| a_{m\ell} \right\|_{C,0,\delta}^2 \\ & \leq C (\left\| b_{m\ell} \right\|_{C,0,\delta-2}^2 + \left[1 + \ell(\ell+1) \right]^2 \left| c_{m\ell} \right|^2) \end{aligned} \tag{C-Est}$$

for each m and ℓ . Indeed, if we multiply **H-Est** and **C-Est** by $[1 + \ell(\ell+1)]^{k-1}$ and sum over m and ℓ , we get the two desired estimates in the statement of the lemma. We will demonstrate this for **H-Est**: after

multiplying **H-Est** by $[1 + \ell(\ell+1)]^{k-1}$, we sum over m and ℓ to get the following three estimates

The rest of the proof is then devoted to prove estimates **H-Est** and **C-Est**.

REDUCTION OF THE PROBLEM

In this section, we reduce the static Einstein vacuum equations into a simpler system involving ODEs, the Laplace equation on M, and first order partial differential equations on ∂M .

Let g be a metric on M of the form $dr^2 + g(r)$, where g(r) is a metric on S^2 for each $r \in [nm_0, \infty)$. The level sets of the function r defines a foliation with leaves denoted by S_r . We define the unit vector field $\mathbf{n} := \frac{\partial}{\partial r}$ that is normal to the foliation. We denote by ∇ and div the covariant derivative and divergence with respect to the induced metric g(r) on S_r , and d the exterior derivative on S_r .

We then define the second fundamental form K as the (0,2) symmetric tensor field on M that is tangential to the leaves S_r of the foliation and satisfies:

for vector fields X, Y on M that are tangential to S_r . We will decompose K into the sum of its traceless and trace parts:

Moreover, $R_{00} := Ric(\mathbf{n}, \mathbf{n})$ and $R_{0i} := Ric(\mathbf{n}, \frac{\partial}{\partial \theta i})$ for i = 1, 2.

In fact, if we in addition know that (g, u) solves the conformal static vacuum Einstein equations for some function u on M, then, due to the contracted Bianchi identities, equations (4.4) and (4.5) need only to be imposed on the boundary for the Ricci curvature to be fully recovered. The next proposition will prove this fact and will demonstrate the desired reduction of our problem.

Reduction Theorem. Let $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})$ be Bartnik data. Let $g = dr^2 + g(r)$ and u be a metric and function on M respectively, where g(r) is a metric on S^2 for every $r \in [nm_0, \infty)$. The pair $(\mathfrak{g}, f) = (e^{-2u}g, e^u)$ solves the static Einstein vacuum equations with Bartnik data $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})$ if and only if (g, u) satisfies

$$\begin{split} \Delta_g u &= 0, \quad on \ M \qquad (4.10) \\ \partial_r tr K + \frac{1}{2} tr K^2 + |\hat{K}|^2 + 2(\partial_r u)^2 &= 0, \quad on \ M \qquad (4.11) \\ \nabla_r \hat{K} + tr K \hat{K} + \left[2 \mathcal{A} u \otimes \mathcal{A} u + g(r) \left((\partial_r u)^2 - |\nabla u|^2 \right) \right] &= 0, \quad on \ M \qquad (4.12) \\ 2 |\nabla u|^2 - 2(\partial_r u)^2 - |\hat{K}|^2 - R_{\partial M} + \frac{1}{2} tr K^2 &= 0, \quad on \ \partial M \qquad (4.13) \\ 2 (\partial_r u) \mathcal{A} u - \mathcal{A} \dot{t} \sigma (\hat{K}) + \frac{1}{2} \mathcal{A} tr K &= 0, \quad on \ \partial M \qquad (4.14) \\ e^{-2u} g|_{\partial M} &= \gamma_{\mathfrak{B}}, \quad on \ \partial M \qquad (4.15) \\ e^u \left(tr K|_{\partial M} - 2 \partial_r u \right) &= tr K_{\mathfrak{B}}, \quad on \ \partial M \qquad (4.16) \end{split}$$

Proof. The "only if " direction is clear from equations (4.2) to (4.5). We prove the "if" direction.

Suppose (g, u) satisfy equations (4.10) to (4.16). It suffices to show that $Ric = 2du \otimes du$. We first decompose the Ricci curvature of g with respect to the foliation. Let Π be the (1,1) projection tensor field defined by

$$\Pi^{\mu}_{\nu} = \delta^{\mu}_{\nu} - \mathbf{n}^{\mu} \mathbf{n}_{\nu} \tag{4.17}$$

We then define the function Q, the 1-form P tangential to the foliation, and the (0,2) symmetric tensor field S tangential to the foliation as follows:

(4.18)

The Ricci curvature of *g* can then be written in the following way:

$$Ric = Q\underline{\mathbf{n}} \otimes \underline{\mathbf{n}} + P \otimes \underline{\mathbf{n}} + \underline{\mathbf{n}} \otimes P + S \tag{4.19}$$

where \underline{n} is the 1-form achieved by lowering the index for n. We will omit the underbar when we write n in components.

Define the function H on M and the 1-form A tangent to the foliation in the following way:

We now compare equations (4.2) - (4.5) with equations (4.11) - (4.14). From Equation (4.2) and (4.11), we deduce on M that

From equation (4.9) and (4.12), we deduce on M that

$$S = 2du \otimes du + \frac{1}{2}\gamma H \tag{4.23}$$

We also have by definition of *A*:

From equation (4.4) and (4.13), it follows that on ∂M ,

$$R - 2Q = 2|\nabla u|^2 - 4\mathbf{n}(u)^2 \tag{4.25}$$

which gives us:

From equation (4.5) and (4.14), we get:

To prove the statement, we just need to show that H, A = 0.

We first prove the following lemma.

Lemma 4.1. Let $dr^2 + g(r)$ be a metric on M where g(r) is a metric on S^2 for every $r \in [nm_0, \infty)$. Suppose that the Ricci decomposition relative to the foliation defined by r, as written in equation (4.19), is

$$Q = 2\mathbf{n}(u)^2$$
, $P = 2\mathbf{n}(u)du + A$, $S = 2du \otimes du + \frac{1}{2}g(r)H$ (4.27)

where u is a harmonic function on M, H is a function, and A is a 1-form tangent to the foliation.

Then A and H satisfy

$$(\nabla_{\mathbf{n}} A)_k + A_i K_k^i + tr K A_k = 0 \tag{4.28}$$

$$\nabla_{\mathbf{n}}H + HtrK = 2div(A) \tag{4.29}$$

Proof. Recall the second Bianchi identity:

$$\frac{1}{2}\nabla_{\nu}R = \nabla^{\mu}R_{\nu\mu} \tag{4.30}$$

where $\mu, \nu = 0, 1, 2$.

We can write the Ricci curvature as follows:

$$= \nabla^{\mu}(2du \otimes du)_{\mu\nu} + \nabla^{\mu}A_{\mu}\mathbf{n}_{\nu} + A_{\mu}\nabla^{\mu}\mathbf{n}_{\nu} + \nabla^{\mu}\mathbf{n}_{\mu}A_{\nu} + \mathbf{n}_{\mu}\nabla^{\mu}A_{\nu} \tag{4.36}$$

$$+ \frac{1}{2}\nabla_{\nu'}H\Pi_{\nu'}^{\nu'} + \frac{1}{2}H\nabla^{\mu}(g_{\mu\nu} - \mathbf{n}_{\mu}\mathbf{n}_{\nu})$$

$$= \nabla_{\nu}|\nabla u|^{2} + \nabla^{\mu}A_{\mu}\mathbf{n}_{\nu} + A_{\mu}K_{\nu}^{\mu} + trKA_{\nu} + \nabla_{\mathbf{n}}A_{\nu}$$

$$+ \frac{1}{2}\nabla_{\nu'}H\Pi_{\nu'}^{\nu'} - \frac{1}{2}HtrK\mathbf{n}_{\nu}$$

where $\Pi_{\mu}^{\nu'} = \delta_{\mu}^{\nu'} - \mathbf{n}^{\nu'}\mathbf{n}_{\mu}$. We also used the fact that $\gamma_{\mu\nu} = g_{\mu'\nu'}\Pi_{\mu}^{\mu'}\Pi_{\nu'}^{\nu'} = g_{\mu\nu} - \mathbf{n}_{\mu}\mathbf{n}_{\nu}$.

Using fermi coordinates (r, θ^1, θ^2) and letting v = i = 1, 2, we get

$$(\nabla_{\mathbf{n}}A)_i + A_j K_i^j + trKA_i = 0 \tag{4.38}$$

Letting $\nu = 0$, we get

We then have that *A* satisfies,

By the existence and uniqueness theory of ODEs, it follows that A=0.

Since div(A) = 0, we get that H satisfies

By invoking again the existence and uniqueness theorem of ODEs, we deduce that H=0.

PROOF OF THE MAIN THEOREM

The reduction theorem in section 4 suggests that we study the map

$$\Psi(\gamma_{\mathfrak{B}}, \frac{1}{2} tr K_{\mathfrak{B}}, g, u) := \begin{pmatrix} \Delta_{g} u \\ \partial_{r} tr K + \frac{1}{2} tr K^{2} + |\hat{K}|^{2} + 2(\partial_{r} u)^{2} \\ \nabla_{r} \hat{K} + tr K \hat{K} + \left[2 \mathcal{A} u \otimes \mathcal{A} u + g(r) \left((\partial_{r} u)^{2} - |\nabla u|^{2} \right) \right] \\ 2|\nabla u|^{2} - 2(\partial_{r} u)^{2} - |\hat{K}|^{2} - R_{\partial M} + \frac{1}{2} tr K^{2} \\ 2(\partial_{r} u) \mathcal{A} u - \mathcal{A} i \mathcal{O}(\hat{K}) + \frac{1}{2} \mathcal{A} tr K \\ e^{-2u} g|_{\partial M} - \gamma_{\mathfrak{B}} \\ tr K|_{\partial M} - e^{-u} \left(tr K_{\mathfrak{B}} + 2e^{u} \partial_{r} u \right) \end{pmatrix}$$

$$(5.1)$$

where trK and \hat{K} are with respect to the metric g, and $R_{\partial M}$ is with respect to the metric $e^{2u}\gamma_{\mathfrak{B}}$. Furthermore, norms $|\cdot|$ used in the second, third and fourth line are with respect to the metric g.

We wish to show that there exists a map taking Bartnik data $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})$ close to Schwarzchild data to a pair (g, u) satisfying $\Psi(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}}, g, u) = 0$, showing that $(\mathfrak{g}, f) = (e^{-2u}g, e^u)$ solves the static Einstein vacuum equations with Bartnik data $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})$. This can be achieved by first attempting to show that the linearization of Ψ with respect to (g, u) at $(\gamma_{\mathfrak{g}_{sc}}, \frac{1}{2}trK_{\mathfrak{g}_{sc}}, g_{sc}, u_{sc})$ is an isomorphism, or merely surjective, and then invoking the implicit function theorem. However, the linearization of the

contracted Codazzi equation, in the fifth line of the definition of Ψ , leads to obstructions to surjectivity stemming from the divergence operator acting on symmetric traceless tensors on S^2 . More specifically, we are faced with the cokernel of the divergence operator: a 6-dimensional space of obstructions equal to the space of conformal Killing vector fields on S^2 .

This difficulty does not preclude the possibility of finding solutions given arbitrary Bartnik data close to Schwarzchild data. A similar situation arises when one attempts to show the existence of metrics on the sphere with prescribed scalar curvature (see [KW75]). The operator of study will not satisfy the conditions for the inverse function theorem, yet existence holds as shown in [AH21]. In our case, we circumvent this difficulty by introducing an artificial object, in the form of a vector field X, to the meaning of a solution to our problem, proving its existence using the implicit function theorem, and then finally showing that this vector field X vanishes, yielding a solution to the original problem.

5.1 DEFINITION OF THE ARTIFICIAL VECTOR FIELD X

As explained in the introduction of section 5, the contracted Codazzi equations give rise to obstructions that are in correspondence with the space of conformal Killing vector fields on S^2 . We will overcome these seeming obstructions by introducing an artificial vector field X to the definition of a solution; this means that the solution will consist of a metric g, a function u, and a vector field X. This needs to be done in a way so that, firstly, the corresponding modified problem is solvable, and secondly, the artificial vector field, in fact, vanishes for a solution to the modified problem, yielding a solution to the original problem. To achieve this, the artificial vector field X needs to be carefully defined, which will require a certain way of uniquely extending conformal Killing fields from S^2 to the ambient manifold M. This procedure will be outlined in this section.

Notably, Huang and An have also introduced an artificial vector field X in [AH21] and [AH22b] for analogous purposes; specifically, they define X to be a vector field that vanishes on the boundary and asymptotically approaches a Killing vector field at infinity. In contrast, we will define X to be a vector field that satisfies $\left(\mathcal{L}_{\frac{\partial}{\partial r}}X\right)^T=0$ on the boundary and asymptotically approaches a conformal killing vector field on (M,g_{sc}) that restricts to a conformal Killing vector field on $(\partial M,\gamma_{S^2})$.

Given a metric g and a vector field X on M, we denote by $\mathcal{L}_{g,conf}X$ and $\Delta_{g,conf}X$ the conformal Lie derivative of g with respect to X and the conformal laplacian of X defined by

$$\mathcal{L}_{g,conf}X := \widehat{\mathcal{L}_{X}g}, \quad \Delta_{g,conf}X := \operatorname{div}_{g}\left(\mathcal{L}_{g,conf}X\right)$$
 (5.2)

where $\widehat{\mathcal{L}_X g}$ is the traceless part of $\mathcal{L}_X g$. It follows that X is conformal Killing on (M,g) if and only if $\mathcal{L}_{g,conf} X = 0$.

Definition 5.1. Given a conformal Killing vector field X_{CK} on $(\partial M, \gamma_{S^2})$, we denote by $\overline{X_{CK}}$ the unique vector field on (M, g_{sc}) extending X_{CK} on ∂M and satisfying the evolution equation

$$\mathcal{L}_{\frac{\partial}{\partial r}}\overline{X_{CK}} = 0, \quad \text{in } M \tag{5.3}$$

Also, we will use " $di\sigma_{\gamma_{S^2}}(X_{CK})$ " to denote both the divergence of X_{CK} on $(\partial M, \gamma_{S^2})$ and the same function extended to a function on M independent of r. It should be clear from context which one we are referring to.

Definition 5.2. Define the space \mathcal{X}_{∞} as the space of conformal killing vector fields X_{∞} on (M, g_{sc}) of the form

$$X_{\infty} = f(r) \left(div_{\gamma_{S^2}}(X_{CK}) \right) \frac{\partial}{\partial r} + h(r) \overline{X_{CK}}$$
 (5.4)

where f = f(r) and h = h(r) are smooth functions on M such that f = 0 and h = 1 on ∂M and X_{CK} is a conformal Killing vector field on $(\partial M, \gamma_{\mathbb{S}^2})$.

In the case that X_{CK} is Killing, equation (5.4) becomes

$$X_{\infty} = h(r)\overline{X_{CK}} \tag{5.5}$$

Lemma 5.3. Let X_{CK} be a nontrivial conformal Killing vector field on $(\partial M, \gamma_{S^2})$.

- (a) Suppose X_{CK} is Killing on $(\partial M, \gamma_{S^2})$. Then $h \equiv 1$ is the unique smooth function h = h(r) on M in which h = 1 on ∂M and X_{∞} , defined by equation (5.5), is conformal Killing on (M, g_{sc}) . In fact, X_{∞} would also be Killing.
- **(b)** Suppose X_{CK} is not Killing on $(\partial M, \gamma_{S^2})$. There exists unique smooth functions f = f(r) and h = h(r) on M such that $f \equiv 0$, $h \equiv 1$ on ∂M and the vector field X_{∞} defined by (5.4) is conformal Killing on (M, g_{sc}) . Furthermore, $f = O(r^2)$ and $h = O(r^2)$.

In particular, \mathcal{X}_{∞} is a 6 dimensional vector space of conformal Killing vector fields on (M, g_{sc}) .

Proof. We will repeatedly use the following identity of the Lie derivative: for any vector fields X, Y, Z and any (0,2) tensor field T on M,

$$\left[\mathcal{L}_X T\right](Y, Z) = X\left(T(Y, Z)\right) - T([X, Y], Z) - T(Y, [X, Z]) \tag{5.6}$$

We first prove (a). Suppose X_{CK} is Killing on $(\partial M, \gamma_{\mathbb{S}^2})$. It is clear that $h(r)\overline{X_{CK}}$ is Killing on (M, g_{sc}) for $h \equiv 1$ on M as it is a rotation vector on the spherically symmetric Schwarzschild manifold. Now suppose h = h(r) is a smooth function such that $h \equiv 1$ on ∂M and $h(r)\overline{X_{CK}}$ is conformal Killing on M. In particular, we have that

$$0 = \left[\mathcal{L}_{h(r)\overline{X_{CK}}} g_{sc} \right] \left(\frac{\partial}{\partial r}, \overline{X_{CK}} \right)$$
 (5.7)

$$= g_{sc}\left(\left[\frac{\partial}{\partial r}, h(r)\overline{X_{CK}}\right], \overline{X_{CK}}\right) + g_{sc}\left(\left[Y, h(r)\overline{X_{CK}}\right], \frac{\partial}{\partial r}\right)$$
 (5.8)

$$=h'(r)g_{sc}(\overline{X_{CK}},\overline{X_{CK}}) \tag{5.9}$$

In view of the fact that $X_{CK} \neq 0$, it follows that $h' \equiv 0$ and so $h \equiv 1$ on M as needed.

We now prove (b). Suppose X_{CK} is not Killing on $(\partial M, \gamma_{S^2})$. Let f = f(r) and h = h(r) be smooth functions on M. Recall that the metric g_{sc} can be written as

$$g_{sc} = dr^2 + r(r - 2m_0)\gamma_{\mathbb{S}^2}$$

Only for the proof of this lemma, we will denote the function $div_{\gamma_{S^2}}(X_{CK})$ by $B_{X_{CK}}$ for simplicity of the notation. Recall that $B_{X_{CK}}$ is understood as a function on M or a function on ∂M depending on the context, and that $B_{X_{CK}}$ as a function on M is constant in r.

Since X_{CK} is not Killing, we have that $B_{X_{CK}}$ is nonzero. Moreover, after fixing a spherical coordinate system on ∂M , the vector field X_{CK} can be written as a linear combination of the vector fields $\nabla_{\gamma_{\mathbb{S}^2}} Y_m^{\ell=1}$, for m=-1,0,1, where $Y_m^{\ell=1}$ are the $\ell=1$ spherical harmonics on ∂M . In particular, it holds that

$$\nabla \nabla_{\gamma_{S^2}} B_{X_{CK}} = -2X_{CK} \tag{5.10}$$

This implies that

For $X_{\infty} := f(r)B_{X_{CK}} \frac{\partial}{\partial r} + h(r)\overline{X_{CK}}$ and arbitrary vector fields Y, Z tangent to the foliation, we compute

$$\left[\mathcal{L}_{X_{\infty}}g_{sc}\right]\left(\frac{\partial}{\partial r},\frac{\partial}{\partial r}\right) = 2g_{sc}\left(\left[\frac{\partial}{\partial r},X_{\infty}\right],\frac{\partial}{\partial r}\right)$$
(5.13)

$$=2f'(r)B_{X_{CK}} (5.14)$$

$$\left[\mathcal{L}_{X_{\infty}}g_{sc}\right]\left(\frac{\partial}{\partial r},Y\right) = g_{sc}\left(\left[\frac{\partial}{\partial r},X_{\infty}\right],Y\right) + g_{sc}\left(\left[Y,X_{\infty}\right],\frac{\partial}{\partial r}\right)$$
(5.15)

$$=h'(r)g_{sc}(\overline{X_{CK}},Y)+f(r)Y(B_{X_{CK}})$$
(5.16)

$$=h'(r)g_{sc}(\overline{X_{CK}},Y)+f(r)g_{sc}(\nabla B_{X_{CK}},Y)$$
 (5.17)

$$= \left(h'(r) - \frac{2}{r(r - 2m_0)}f(r)\right)g_{sc}(\overline{X_{CK}}, Y)$$
 (5.18)

$$= f(r) \ B_{X_{CK}} \ trK_{sc} \ g_{sc}(Y,Z) + r(r-2m_0)h(r) \ B_{X_{CK}}\gamma_{S^2}(Y,Z) \qquad (5.21)$$

$$= [f(r)trK_{sc} + h(r)] \ B_{X_{CK}}g_{sc}(Y,Z) \qquad (5.22)$$

In the above calculation, we used the fact that X_{CK} is conformal Killing on each leaf and hence $\mathcal{L}_{X_{CK}}\gamma_{S^2} = B_{X_{CK}}\gamma_{S^2}$.

It follows that $\mathcal{L}_{X_{\infty}}g_{sc}$ is conformal to g_{sc} , $f \equiv 0$ and $h \equiv 1$ on ∂M if and only if the pair (f,h) satisfy the following on $[nm_0,\infty)$.

$$\begin{cases} 2f'(r) = f(r)trK_{sc} + h(r), \\ h'(r) = \frac{2}{r(r-2m_0)}f(r), \\ f(nm_0) = 0, \\ h(nm_0) = 1 \end{cases}$$

This decouples to the following initial value problems for f and h on $[nm_0, \infty)$.

$$\begin{cases} h'(r) = \frac{2}{r(r-2m_0)} f(r) \\ h(nm_0) = 1 \end{cases}$$
 (5.25)

Invoking the existence and uniqueness theorem for ODEs, it follows that there exists unique smooth functions f and g satisfying the above initial value problems.

We have then proven that there exists unique smooth functions f = f(r) and h = h(r) on M such that $f \equiv 0$, $h \equiv 1$ on ∂M and the vector field X_{∞} is conformal Killing on (M, g_{sc}) .

We utilize Fuchsian theory to establish that both f and h are $O(r^2)$. We first observe that the ODE for f in equation (5.24) has a regular singular point at infinity. We can then express f as a Frobenius series as follows (see [BO13]):

$$f(r) = (r - m_0)^{\alpha} \sum_{n=0}^{\infty} a_n (r - m_0)^{-n}$$
 (5.26)

where $\alpha \in \mathbb{R}$ is to be determined and $a_0 \neq 0$. We substitute this expression of f into the ODE in (5.24) to get

$$\sum_{n=0}^{\infty} a_n(\alpha - n)(\alpha - n - 1)(r - m_0)^{\alpha - n - 2} - \sum_{n=0}^{\infty} a_n(\alpha - n)(r - m_0)^{\alpha - n - 2} \left(1 + \frac{m_0^2}{r(r - 2m_0)}\right) + 2m_0^2 \sum_{n=0}^{\infty} a_n(r - m_0)^{\alpha - n - 4} \frac{(r - m_0)^4}{r^2(r - 2m_0)^2}$$
(5.27)

Upon examining the highest power of $r - m_0$, we deduce that α must satisfy the equation

$$\alpha(\alpha - 1) - \alpha = 0 \tag{5.28}$$

implying that α can only be 0 or 2. It follows that $f = O(r^2)$. The fact that $h = O(r^2)$ follows immediately from equation (5.25).

Remark 5.4. Note that any vector field X_{∞} in \mathcal{X}_{∞} satisfies

$$\left(\mathcal{L}_{\frac{\partial}{\partial r}}X_{\infty}\right)^T=0,\qquad \text{on }\partial M$$

Hence, the lemma proves an existence and uniqueness result for an overdetermined problem: for any conformal Killing vector field X_{CK} on $(\partial M, \gamma_{S^2})$, there exists a unique conformal Killing vector field X_{∞} on (M, g_{sc}) satisfying the following boundary conditions on ∂M :

$$X_{\infty}|_{\partial M} = X_{CK}, \quad \left(\mathcal{L}_{\frac{\partial}{\partial r}} X_{\infty}\right)^{T} = 0$$
 (5.29)

Furthermore, X_{∞} will of the form as in equation (5.4) for some functions f = f(r) and h = h(r).

Definition 5.5. We define $\widehat{\mathcal{X}}^2_{\delta}(M)$ to be all vector fields $X \in \mathcal{X}^2_{\delta}(M)$ (see definition 2.5) such that $X|_{\partial M}$ is tangent to ∂M and $\left(\mathcal{L}_{\frac{\partial}{\partial r}}X\right)^T=0$ on ∂M . The artificial vector field X will be chosen to live in the space $\widehat{\mathcal{X}}^2_{\delta}(M) \oplus \mathcal{X}_{\infty}(M)$. The reasons for this choice will be clear in the next sections.

5.2 DEFINITION AND EXISTENCE OF THE MODIFIED SOLUTION

In this section, we will define the modified problem and its solutions, which we call "the modified solutions", and prove their existence. Here and onwards, we fix a number $\delta \in (-1, -\frac{1}{2}]$ and an integer $k \ge 5$.

Let η be a smooth cut off function on $[nm_0, \infty)$ satisfying $\eta(r) = 1$ for $r \ge nm_0 + 2$ and $\eta(r) = 0$ for $r \le nm_0 + 1$. Given $X \in \widehat{\mathcal{X}}^2_{\delta}(M) \oplus \mathcal{X}_{\infty}(M)$, define the function F(X) on M by

$$F(X) := e^{-r^4 \eta(r)|X|^2} \tag{5.30}$$

where $|\cdot|$ is taken with respect to g_{sc} .

Given $g = dr^2 + g(r) \in \mathcal{M}^k_{\delta}(M)$ and $X_{\infty} \in \mathcal{X}_{\infty}$, define $\omega(g, X_{\infty})$ to be the 1-form on ∂M achieved by lowering the index of $X_{\infty}|_{\partial M}$ with respect to $g(nm_0)$. Note that $X_{\infty}|_{\partial M}$ is a conformal Killing field on $(\partial M, \gamma_{S^2})$ by definition of the space \mathcal{X}_{∞} .

Define Φ by:

$$\begin{split} \Phi: \mathcal{M}^{k+1}(\partial M) \times H^k(\partial M) \times \mathcal{M}^k_{\delta}(M) \times \mathcal{A}^{(2,k+1)}_{\delta}(M) \times \left(\widehat{\mathcal{X}}^2_{\delta}(M) \oplus \mathcal{X}_{\infty}(M)\right) \\ \to \mathcal{A}^{(0,k-1)}_{\delta-2}(M) \times L^2_{\delta-2}\left([nm_0,\infty); H^k(S^2)\right) \times L^2_{\delta-2}\left([nm_0,\infty); \mathcal{H}^k(S^2)\right) \times \mathcal{X}^0_{\delta-2}(M) \\ \times H^{k-1}(\partial M) \times \Omega^{k-1}(\partial M) \times \mathcal{H}^k(\partial M) \times H^k(\partial M) \end{split}$$

$$\Phi(\gamma_{\mathfrak{B}},\frac{1}{2}trK_{\mathfrak{B}},g,u,X) := \begin{pmatrix} \Delta_{g}u & \text{on } M \\ \partial_{r}trK + \frac{1}{2}trK^{2} + |\hat{K}|^{2} + 2(\partial_{r}u)^{2} & \text{on } M \\ \nabla_{r}\hat{K} + trK\hat{K} + \left[2du \otimes du + g(r)\left((\partial_{r}u)^{2} - |\nabla u|^{2}\right)\right] & \text{on } M \\ \Delta_{g,conf}(F(X)X) & \text{on } M \\ 2|\nabla u|^{2} - 2(\partial_{r}u)^{2} - |\hat{K}|^{2} - R_{\partial M} + \frac{1}{2}trK^{2} & \text{on } \partial M \\ 2(\partial_{r}u)du - div(\hat{K}) + \frac{1}{2}dtrK + \omega(g,X_{\infty}) & \text{on } \partial M \\ e^{-2u}g|_{\partial M} - \gamma_{\mathfrak{B}} & \text{on } \partial M \\ trK|_{\partial M} - e^{-u}\left(trK_{\mathfrak{B}} + 2e^{u}\partial_{r}u\right) & \text{on } \partial M \end{pmatrix}$$

$$(5.31)$$
where Y_{-} is the prejection of Y_{-} ento Y_{-} (M), trV_{-} and \hat{K} are with respect

where X_{∞} is the projection of X onto $\mathcal{X}_{\infty}(M)$, trK and \hat{K} are with respect to the metric g, and $R_{\partial M}$ is with respect to the metric $e^{2u}\gamma_{\mathfrak{B}}$. Furthermore, norms $|\cdot|$ used in the second, third and fifth equation are with respect to the metric g.

Definition 5.6. Given Bartnik data $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})$, we say that a 3-tuple (g, u, X) is a modified solution if $\Phi(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}}, g, u, X) = 0$.

Remark 5.7. In view of proposition , a modified solution is a solution to the original problem if and only if X = 0.

The main tool to obtain the existence of the modified problem is the implicit function theorem on Banach manifolds (see [AMR12]), which is stated here for convenience.

Theorem 5.8. Let $U \subset E$, $V \subset F$ be open subsets of Banach spaces E and F, and let $\Psi: U \times V \to G$ be a C^r map to a Banach space G, with $r \geq 1$. For some $x_0 \in U$, $y_0 \in V$, assume the partial derivatives in the second argument $D_2\Psi(x_0,y_0): F \to G$ is an isomorphism. Then there are neighbourhoods U_0 of x_0 and W_0 of $\Psi(x_0,y_0)$ and a unique C^r map $H: U_0 \times W_0 \to V$ such that for all $(x,w) \in U_0 \times W_0$, $\Psi(x,H(x,w)) = w$.

The map Φ is indeed C^1 near $(\gamma_{\mathfrak{g}_{sc}}, \frac{1}{2}trK_{\mathfrak{g}_{sc}}, g_{sc}, u_{sc}, 0)$. To see this, we first note the following:

- The map $u \mapsto du \otimes du$ is C^1 from $\mathcal{A}^{(2,k+1)}_{\delta}(M)$ to $H^1_{2\delta-2}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$.
- The map $g \mapsto trK$ is C^1 from $\mathcal{M}^k_{\delta}(M)$ to $H^1_{\delta-1}\left([nm_0,\infty);H^k(S^2)\right)$.
- The map $g \mapsto \hat{K}$ is \mathcal{C}^1 from $\mathcal{M}^k_{\delta}(M)$ to $H^1_{\delta-1}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$.

This immediately shows that each line, excluding the fourth line, in the definition of Φ is \mathcal{C}^1 . It remains to show that the map $(g,X)\mapsto \Delta_{g,conf}(F(X)X)$ is \mathcal{C}^1 from $\mathcal{M}^k_\delta(M)\times\left(\widehat{\mathcal{X}}^2_\delta(M)\oplus\mathcal{X}_\infty(M)\right)$ to $\mathcal{X}^0_{\delta-2}$ near $(g_{sc},0)$. This follows directly from the smoothness of F(X) and the following identity of the conformal laplacian (see [Yor74]):

$$\Delta_{g,conf}(F(X)X)_{\mu} = \Delta_{g}(F(X)X)_{\mu} + \frac{1}{3}\nabla_{\mu}\left(\operatorname{div}_{g}(F(X)X)\right) + R_{\mu\nu}F(X)X^{\nu}$$
(5.32)

We can then differentiate Φ at $(\gamma_{\mathfrak{g}_{\mathfrak{sc}}}, \frac{1}{2}trK_{\mathfrak{g}_{\mathfrak{sc}}}, g_{sc}, u_{sc}, 0)$ and study its derivative.

Let $D\Phi_{sc}$ denote the derivative of Φ with respect to the last three components evaluated at $(\gamma_{\mathfrak{g}_{sc}}, \frac{1}{2}trK_{\mathfrak{g}_{sc}}, g_{sc}, u_{sc}, 0)$ where

$$D\Phi_{sc}: T_{g_{sc}}\mathcal{M}_{\delta}^{k} \times \mathcal{A}_{\delta}^{(2,k+1)} \times \left(\widehat{\mathcal{X}}_{\delta}^{2}(M) \oplus \mathcal{X}_{\infty}(M)\right)$$

$$\to \mathcal{A}_{\delta-2}^{(0,k-1)}(M) \times L_{\delta-2}^{2}\left([nm_{0},\infty); H^{k}(S^{2})\right) \times L_{\delta-2}^{2}\left([nm_{0},\infty); \mathcal{H}^{k}(S^{2})\right)$$

$$\times H^{k-1}(\partial M) \times \Omega^{k-1}(\partial M) \times \mathcal{H}^{k}(\partial M) \times H^{k}(\partial M)$$

Proposition 5.9. $D\Phi_{sc}$ is an isomorphism.

Proof. The proof of this will be the content of section (5.4).

We can now conclude the existence theorem for the extended problem.

Theorem 5.10. There exists a neighbourhood \mathcal{U} of $(\gamma_{\mathfrak{g}_{\mathfrak{sc}}}, \frac{1}{2}trK_{\mathfrak{g}_{\mathfrak{sc}}})$ in $\mathcal{M}^{k+1}(\partial M) \times H^k(\partial M)$ and a unique \mathcal{C}^1 map $\mathbf{H}: (\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}}) \mapsto (g, u, X)$ on \mathcal{U} into $\mathcal{M}^k_{\delta}(M) \times \mathcal{A}^{(2,k+1)}_{\delta}(M) \times \widehat{\mathcal{X}}^2_{\delta}(M) \oplus \mathcal{X}_{\infty}(M)$ satisfying

$$\Phi(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}}, \mathbf{H}(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})) = 0, \quad \text{for all } (\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}}) \in \mathcal{U} \quad (5.33)$$

Proof. Follows from proposition (5.9) and the implicit function theorem on Banach manifolds.

5.3 THE VANISHING OF X FOR MODIFIED SOLUTIONS (g, u, X)

The next step is to show that if (g, u, X) is a modified solution, then X = 0, yielding a solution (g, u) to the conformal static vacuum Einstein equations.

Let $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}}) \in \mathcal{U}$ be Bartnik data and let $(g, u, X) := \mathbf{H}(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})$ be the corresponding modified solution.

We first find the Ricci curvature of the metric *g*.

Proposition 5.11. The Ricci decomposition of $g = dr^2 + g(r)$ relative to the foliation defined by r is given by

$$Ric = Q\underline{\mathbf{n}} \otimes \underline{\mathbf{n}} + P \otimes \underline{\mathbf{n}} + \underline{\mathbf{n}} \otimes P + S \tag{5.34}$$

$$Q = 2n(u)^2$$
, $P = 2n(u) du + A$, $S = 2 du \otimes du + \frac{1}{2}g(r)H$ (5.35)

where H and A are the unique function on M and 1-form on M tangent to the foliation satisfying:

$$\begin{cases} \nabla_n A_k + A_i K_k^i + trK A_k = 0, & \text{on } M \\ A = \omega(g, X_\infty), & \text{on } \partial M \end{cases}$$
 (5.36)

$$\begin{cases} \nabla_n H + H t r K = 2 div(A), & on M \\ H = 0, & on \partial M \end{cases}$$
 (5.37)

Proof. Lemma (4.1) shows that A and H satisfy the desired transport equations on M. The boundary condition for A and H follow by comparing equations

$$2|\nabla u|^2 - 2(\partial_r u)^2 - |\hat{K}|^2 - R_{\partial M} + \frac{1}{2}trK^2 = 0$$
, and $2(\partial_r u) \Delta u - div(\hat{K}) + \frac{1}{2}dtrK + \omega(g, X_\infty) = 0$ with equations (4.4) and (4.5).

The relation between the Ricci curvature of g and u as described in the above proposition leads to the following regularity result.

Proposition 5.12. *The following holds for any modified solution* (g, u, X)*.*

• The Ricci curvature of g is C^1 away from the boundary. Furthermore, there exists a universal constant C > 0 such that for $R > nm_0$,

$$\sup_{r>R} r^2(|Ric| + r|\nabla Ric|) \le C \|\gamma_{\infty} - \gamma_{S^2}\|_{\mathcal{H}^k(\partial M)} + o(R^{\delta})$$
 (5.38)

as R goes to ∞ .

• The vector field F(X)X lies in $\mathcal{X}^3_{\delta}(M)$.

Proof. We first find explicit expressions for A and H. Letting (r, θ^1, θ^2) be fermi coordinates, we compute for i = 1, 2,

$$\nabla_n A_i = \partial_r A_i - \Gamma_{0i}^j A_j \tag{5.39}$$

$$= \partial_r A_i - K_i^j A_j \tag{5.40}$$

Equation (5.36) for A then becomes

$$\begin{cases} \partial_r A_i + trKA_i = 0, & \text{on } M \\ A = \omega(g, X_\infty), & \text{on } \partial M \end{cases}$$
 (5.41)

which gives

$$A_i(r) = \frac{1}{L(r)}\omega_i \tag{5.42}$$

where
$$L(r) := \exp\left(\int_{nm_0}^r trK(s)ds\right)$$
.

We then solve equation (5.37) for H to obtain

$$H(r) = \frac{1}{L(r)} \int_{nm_0}^{r} L(s) 2 div(A(s)) ds$$
 (5.43)

From proposition (2.10), we have

$$\left|trK - \frac{2}{r}\right| \in H^1_{\delta-1}\left([nm_0, \infty); H^k(S^2)\right), \qquad \hat{K} \in H^1_{\delta-1}\left([nm_0, \infty); \mathcal{H}^k(S^2)\right)$$

It then follows that $A \in H^2_{loc}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$ and $div(A) \in H^1_{loc}\left([nm_0,\infty);\mathcal{H}^{k-1}(S^2)\right)$, which in turn implies that $H \in H^2_{loc}\left([nm_0,\infty);H^{k-1}(S^2)\right)$.

Furthermore, since $k \ge 5$, the Sobolev embedding described in proposition (2.10) imply that trK and \hat{K} are continuous in r, have 3 continuous angular derivatives, and satisfy

$$trK = \frac{2}{r} + o(r^{\delta - 1}), \quad |\hat{K}| = o(r^{\delta - 1})$$
 (5.45)

Using the asymptotics of trK described above, we derive the asymptotics of L to be

$$L(r)^{-1} = \mathcal{O}(r^{-2}), \quad \partial_r(L(r)^{-1}) = \mathcal{O}(r^{-3}), \quad |\nabla (L(r)^{-1})| = \mathcal{O}(r^{-3})$$
(5.46)

as r goes to ∞ .

It follows that *A* and *H* have continuous first derivatives and satisfy

$$|A(r)| = \mathcal{O}(r^{-3}), \quad |\partial_r A(r)| = \mathcal{O}(r^{-4}), \quad |\nabla A(r)| = \mathcal{O}(r^{-4})$$
 (5.47)

$$H(r) = \mathcal{O}(r^{-2}), \quad \partial_r H(r) = \mathcal{O}(r^{-3}), \quad |\nabla H(r)| = \mathcal{O}(r^{-3})$$
 (5.48)

By virtue of the fact that (g, u, X) is a modified solution, we have

$$\partial_r^2 u + tr K \partial_r u + \Delta_{g(r)} u = 0 (5.49)$$

The above equation together with the fact that $u \in \mathcal{A}^{(2,k+1)}_{\delta}(M)$ then implies $\partial_r^2 u \in H^1_{\delta-2}\left([nm_0,\infty);H^{k-2}(S^2)\right)$. This in particular implies that $\partial_r u, |\nabla u| \in H^2_{\delta-1}\left([nm_0,\infty);H^{k-2}(S^2)\right)$. Using the Sobolev embeddings again and the fact that $k \geq 5$, we deduce that $\partial_r u, |\nabla u|$ have continuous first derivatives and satisfy

$$\partial_r u = o(r^{\delta - 1}), \quad \partial_r^2 u = o(r^{\delta - 2}), \quad |\nabla \partial_r u| = o(r^{\delta - 2})$$
 (5.50)

Having achieved the asymptotics for u, we can now derive an explicit expression for the leading order term for H and ∇H . Using the Gauss equation, we get

$$r^{2}H(r) = r^{2}Rg(r) - 2 + 2r^{2}(\partial_{r}u)^{2} + r^{2}|\hat{K}|^{2} - \frac{r^{2}}{2}\left(trK - \frac{2}{r}\right)^{2} + 2r\left(trK - \frac{2}{r}\right)$$

$$= r^{2}R_{g(r)} - 2 + o(r^{\delta})$$
(5.52)

where we have used equations (5.50) and (5.45).

It then follows that

$$H(r) = r^{-2}(R_{\gamma_{\infty}} - 2) + o(r^{\delta - 2}), \quad |\nabla H(r)| = r^{-3} \left(|R_{\gamma_{\infty}} - 2|^2 + |AR_{\gamma_{\infty}}|_{\gamma_{\infty}}^2 \right)^{1/2} + o(r^{\delta - 3})$$
(5.53)

where $|\cdot|_{\gamma_{\infty}}$ is the γ_{∞} -norm.

In view of the expression of the Ric in terms of u, A, and H in equations (5.34) and (5.35), we deduce the desired regularity of Ric, namely that it is C^1 away from the boundary. We are now in a position to prove equation (5.38). Using again equations (5.34) and (5.35), we estimate |Ric| and $|\nabla Ric|$: for some universal constant C > 0, we have

$$|Ric| \le C(|\nabla u|^2 + |A| + |H|), \quad |\nabla Ric| \le C(|\nabla^2 u|^2 + |\nabla A| + |\nabla H|)$$
(5.54)

Using the asymptotics of u, A, and H laid out in equations (5.50), (5.47) and (5.53), we get that for $R > nm_0$,

$$\sup_{r>R} r^2(|Ric| + r|\nabla Ric|) \le C \sup_{S^2} (|R_{\gamma_{\infty}} - 2| + |AR_{\gamma_{\infty}}|_{\gamma_{\infty}}) + o(R^{\delta}) \quad (5.55)$$

$$\leq C \|\gamma_{\infty} - \gamma_{\mathbb{S}^2}\|_{\mathcal{C}^3(S^2)} + o(R^{\delta}) \tag{5.56}$$

$$\leq C \|\gamma_{\infty} - \gamma_{\mathbb{S}^2}\|_{\mathcal{H}^k(\mathbb{S}^2)} + o(R^{\delta}) \tag{5.57}$$

as R goes to ∞ . In the last line, we have used again the Sobolev embeddings and the fact that $k \geq 5$. We have also allowed the constant C to change from line to line while staying universal, i.e. independent of g and u.

We turn our attention to the second statement of the proposition. It suffices to show that X_0 admits 3 derivatives. By virtue of the fact that (g, u, X) is a modified solution, we have

$$\partial_r trK + \frac{1}{2} trK^2 + |\hat{K}|^2 = -2(\partial_r u)^2$$
 (5.58)

$$\nabla_r \hat{K} + tr K \hat{K} = -2 \mathcal{A} u \otimes \mathcal{A} u - g(r)((\partial_r u)^2 - |\nabla u|^2)$$
 (5.59)

Thanks to equation (5.50), we have that $|\nabla u| \in H^2_{\delta-1}\left([nm_0,\infty);H^{k-2}(S^2)\right)$ and so admits 2 radial derivatives. Hence, the above equations directly impy that trK and \hat{K} admit 3 radial derivative and, in fact, live in $H^3_{\delta-1}\left([nm_0,\infty);H^k(S^2)\right)$ and $H^3_{\delta-1}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$ respectively. Due to the evolution equation

$$\partial_r g(r) = tr K g(r) + 2\hat{K}, \tag{5.60}$$

we deduce that $g(r) \in H^4_{loc}\left([nm_0,\infty); \mathcal{H}^k(S^2)\right)$ and so admits 4 radial derivatives. By the Sobolev embedding and the fact that $k \geq 5$, this implies that $g(r), \partial_r g(r), \partial_r^2 g(r)$ are continuous in r and are \mathcal{C}^3 on the sphere. We conclude that the metric $g = dr^2 + g(r)$ is of class \mathcal{C}^3 . Since F(X)X satisfy the elliptic equation $\Delta_{g,conf}F(X)X = 0$ with respect to a \mathcal{C}^3 metric, standard localized interior estimates show that F(X)X lives in $\mathcal{X}^3_\delta(M)$ (see for example [CBo8] appendix II).

Remark 5.13. Stronger regularity results can be proven for the modified solution (g, u, X). Specifically, g, u, and X are in fact smooth away from the boundary. Nonetheless, the above regularity result is sufficient for our purpose. We will use it to show the nonexistence of nontrivial conformal Killing fields on (M, g) (see lemma (5.14)).

We now show that X = 0. Letting $\bar{X} := F(X)X$, we note that $\Delta_{g,conf}\bar{X} = 0$ on M in light of the fourth line in the definition of Φ and the fact that (g,u,X) is a modified solution. We decompose X as follows,

$$X = X_0 + X_{\infty} \tag{5.61}$$

where $X_0 \in \widehat{\mathcal{X}}^2_{\delta}(M)$ and $X_{\infty} \in \mathcal{X}_{\infty}$. We make the following observations:

- If $\limsup_{r\to\infty} r^4|X|^2 = \infty$, then F(X) decays exponentially in r. Since $|X| = |X_\infty + X_0| = O(r^2)$ by lemma 5.3, we deduce that $|\bar{X}|$ decays exponentially in r.
- If $\limsup_{r\to\infty} r^4|X|^2 < \infty$, then F(X) = O(1) and so $|\bar{X}| = O(r^{-2})$.

The above implies that $|\bar{X}| = O(r^{-2})$. This allows us to perform the following integration-by-parts computation:

The above calculation is valid since $|\mathcal{L}_{g,conf}\bar{X}|^2$ is integrable and the boundary integral at infinity vanishes.

We now compute $\mathcal{L}_{g,conf}\bar{X}(\bar{X},\frac{\partial}{\partial r})$ on ∂M in order to evaluate the boundary integral in equation (5.63). Recall that we decomposed X as follows,

Let $g \in M^k_{\delta}(M)$ satisfy the statement of proposition (5.12) (i.e. Ric is \mathcal{C}^1 away from ∂M and equation (5.38) holds). Suppose also that $\|\gamma_{\infty} - \gamma_{\mathbb{S}^2}\|_{\mathcal{H}^k(\mathbb{S}^2)} < \epsilon$. If $Z \in \mathcal{X}^3_{\delta}(M)$ is a conformal Killing vector field on (M,g), then Z = 0.

Proof. Let $Z \in \mathcal{X}^3_{\delta}(M)$ is a conformal Killing vector field on (M, g). A direct computation shows that we can express the third covariant derivative of Z as follows.

An application of a Hardy-type inequality shows that there exists an $R_0 > nm_0$ depending only on g and a positive constant C depending only on δ such that for any $R \geq R_0$ and any vector field $Z \in \mathcal{X}^3_{\delta}(M)$,

where the constant *C* is allowed to change from line third to fourth line while staying universal, *i*.e. independent of *Z*, *R*, and *g*.

Choosing ϵ small enough and R large enough so that $C(\epsilon + R^{2\delta}) < 1$ implies that Z = 0 on $[R, \infty) \times S^2$.

Since Z satisfies the elliptic equation $\Delta_{g,conf}Z=0$ and vanishes on an open set, standard arguments then imply that Z=0 on M (see for example [CO81]).

Remark 5.15. The nonexistence of nontrivial conformal Killing vector fields vanishing at infinity on asymptotically flat manifolds has already been established in [CO81] and [Yor74]. The above lemma extends this nonexistence result to a broader class of metrics, including some that are not asymptotically flat.

After possibly shrinking the neighbourhood \mathcal{U} of $(\gamma_{\mathfrak{g}_{\mathfrak{sc}}}, \frac{1}{2}trK_{\mathfrak{g}_{\mathfrak{sc}}})$ and using the continuity of \mathcal{H} , we can assume that for $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}}) \in \mathcal{U}$, the metric g of the modified solution $\mathcal{H}(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}}) = (g, u, X)$ satisfies

 $\|\gamma_{\infty} - \gamma_{S^2}\|_{\mathcal{H}^k(S^2)} < \epsilon$. Since \bar{X} is conformal Killing on (M,g) and lives in $\mathcal{X}^3_{\delta}(M)$, the above lemma then implies that $\bar{X}=0$, and hence X=0. We then finally conclude, by remark 5.7, that (g, u) is a solution to the conformal static vacuum Einstein equations with Bartnik data $(\gamma_{\mathfrak{B}}, \frac{1}{2}trK_{\mathfrak{B}})$. This concludes the proof of the main theorem.

Step 2: We will show if $\tilde{u} \in \mathcal{A}_{\delta}^{(2,k+1)}$ satisfies (5.91) and (5.92) with ψ and Γ given by equations (5.93) and (5.94), then there exists a unique $\tilde{g} \in T_{g_{sc}}\mathcal{M}_{\delta}^{k}(M)$ and a unique conformal Killing field $\tilde{\omega}$ satisfying equations (5.83) to (5.85) and (5.87) to (5.90).

Step 3: We will show that there exists a unique vector field $\tilde{Y} \in \widehat{\mathcal{X}}^2_{\delta}(M)$ satisfying $\Delta_{g_{sc},conf}\tilde{Y} = D$.

The above 3 steps will then imply that there exists a unique $(\tilde{g}, \tilde{u}, \tilde{X})$ in the domain of $D\Phi_{sc}$ solving equations (5.83) to (5.90). In particular, \tilde{u} and \tilde{g} are achieved from steps 1 and 2 respectively and $\tilde{X} := \tilde{Y} + \tilde{\omega}$, where \tilde{Y} and $\tilde{\omega}$ are achieved from steps 2 and 3 respectively.

Step 1: Solving for \tilde{u}

To study the boundary value problem in (5.91) and (5.92), we will investigate the properties of the corresponding non-local elliptic operator \mathcal{P}_{sc} , which maps $\mathcal{A}^{(2,k+1)}_{\delta}(M)$ into $\mathcal{A}^{(0,k-1)}_{\delta-2}(M) \times H^{k-1}(\partial M)$ and is defined by

$$\mathcal{P}_{sc}(\tilde{u}) := \begin{pmatrix} \Delta_{g_{sc}} \tilde{u} - \frac{4m_0^2}{[r(r-2m_0)]^2} \tilde{u} + \frac{n(n-2)m_0}{2} \frac{4m_0^2}{[r(r-2m_0)]^2} \left(\frac{4-n}{n(n-2)m_0} \tilde{u}|_{\partial M} + \partial_r \tilde{u}|_{\partial M} \right) \\ \frac{2}{nm_0} \partial_r \tilde{u} + \Delta \tilde{u} + \frac{2}{n^2(n-2)m_0^2} \tilde{u} \end{pmatrix}$$
(5.105)

In fact, this operator will turn out to be Fredholm of index o as shown in the following proposition.

Remark 5.18. In [AH21] and [AH22b], the authors study the static Einstein vacuum equations in a gauge different from the one used in this paper. Specifically, they study an operator analogous to the operator Φ considered here. They achieve that the linearization of their operator is an isomorphism, so as to invoke the implicit function theorem, by first establishing that it is Fredholm of index 0 and then showing that its kernel is trivial. Our approach here is similar except that our gauge allows us to decouple the equations; this decoupling reduces the task of proving that $D\Phi_{sc}$ is an isomorphism to proving that a much simpler operator, \mathcal{P}_{sc} acting on the linearization of the lapse function \tilde{u} , is an isomorphism. Specifically, we will establish that \mathcal{P}_{sc} is Fredholm of index 0 and has a trivial kernel. The remaining parameters, \tilde{g} and \tilde{X} , are governed by straightforward ODEs with \tilde{u} appearing in the forcing term, and the fact that $D\Phi_{sc}$ is an isomorphism will follow readily (see **Step 2**).

Proposition 5.19. Fix $\delta \in (-1, -\frac{1}{2}]$ and $k \in \mathbb{Z}_{\geq 0}$. Let $T : \mathcal{A}_{\delta}^{(2,k+1)}(M) \to H^{k-1}(\partial M)$ and $S : \mathcal{A}_{\delta}^{(2,k+1)}(M) \to H^{k-1}(\partial M)$ be operators defined by

$$T(\tilde{u}) := \partial_r \tilde{u} + \mu \tilde{u} \tag{5.106}$$

$$S(\tilde{u}) := \Delta_{\gamma_{sc}} \tilde{u} + \beta_1 \partial_r \tilde{u} + \beta_2 \tilde{u} \tag{5.107}$$

where μ , β_1 , $\beta_2 \in H^k(\partial M)$.

Let \mathcal{P} be the nonlocal elliptic differential operator defined by

$$\mathcal{P}: \mathcal{A}^{(2,k+1)}_{\delta}(M) \to \mathcal{A}^{(0,k-1)}_{\delta-2}(M) \times H^{k-1}(\partial M)$$

$$\mathcal{P}(\tilde{u}) := \begin{pmatrix} \Delta_{g_{sc}} \tilde{u} - V_1 \tilde{u} - V_2 \overline{T(\tilde{u})} \\ S(\tilde{u}) \end{pmatrix}$$
 (5.108)

where $V_1, V_2 \in H^1_{-3}([nm_0, \infty); H^k(S^2))$ and $\overline{T(\overline{u})}$ is the function on M defined by $(r, p) \mapsto T(\overline{u})(p)$ for $(r, p) \in M$. Then \mathcal{P} is Fredholm of index 0.

Proof. Decompose the operator $\mathcal{P} = \mathcal{P}_1 + \mathcal{P}_2$, where the operators $\mathcal{P}_1, \mathcal{P}_2$: $\mathcal{A}^{(2,k+1)}_{\delta}(M) \to \mathcal{A}^{(0,k-1)}_{\delta-2}(M) \times H^{k-1}(\partial M)$ are defined by

$$\mathcal{P}_1(ilde{u}) := egin{pmatrix} \Delta_{g_{sc}} ilde{u} \ \Delta_{\gamma_{sc}} ilde{u} \end{pmatrix}, \qquad \mathcal{P}_2(ilde{u}) := egin{pmatrix} -V_1 ilde{u} - V_2\overline{T(ilde{u})} \ eta_1\partial_r ilde{u} + eta_2 ilde{u} \end{pmatrix}$$

In light of proposition (2.10), we observe that \mathcal{P}_2 is a compact operator. Indeed, for any $\tilde{u} \in \mathcal{A}^{(2,k+1)}_{\delta}$, we have that $-V_1\tilde{u} - V_2\overline{T(\tilde{u})}$ lives in $H^1_{-3}\left([nm_0,\infty);H^k(S^2)\right)$ which compactly embeds in $\mathcal{A}^{(0,k-1)}_{\delta-2}(M)$, and $\beta_1\partial_r\tilde{u} + \beta_2\tilde{u}$ lives in $H^k(\partial M)$ which compactly embeds in $H^{k-1}(\partial M)$. To show that \mathcal{P} is Fredholm of index 0, it then suffices to show that \mathcal{P}_1 is Fredholm of index 0 (see [Sch71])

By theorem 3.1, the operator Q defined by:

$$\mathcal{Q}(ilde{u}) := egin{pmatrix} \Delta_{\mathcal{g}_{sc}} ilde{u} \ ilde{u} \end{pmatrix}$$

is an isomorphism from $\mathcal{A}_{\delta}^{(2,k+1)}$ to $\mathcal{A}_{\delta-2}^{(0,k-1)}(M) \times H^{k+1}(\partial M)$.

We also recall the following standard result on the laplacian on compact manifolds: The operator $\Delta_{\gamma_{sc}}: H^{k+1}(\partial M) \to H^{k-1}(\partial M)$ is Fredholm of index 0. In fact, the kernel is the one-dimensional space of constant functions on ∂M and the cokernel is the same since $\Delta_{\gamma_{sc}}$ is self-adjoint.

We observe that $\mathcal{P}_1 = (\mathcal{ID}, \Delta_{\gamma_{sc}}) \circ \mathcal{Q}$, where

$$(\mathcal{ID}, \Delta_{\gamma_{sc}}): \mathcal{A}^{(0,k-1)}_{\delta-2}(M) \times H^{k+1}(\partial M) \to \mathcal{A}^{(0,k-1)}_{\delta-2}(M) \times H^{k-1}(\partial M)$$

is defined by

$$(\mathcal{ID}, \Delta_{\gamma_{sc}})(\tilde{v}, f) := (\tilde{v}, \Delta_{\gamma_{sc}} f)$$

Since $(\mathcal{ID}, \Delta_{\gamma_{sc}})$ is Fredholm of index o and \mathcal{Q} is an isomorphism, it then follows that \mathcal{P}_1 is Fredholm of index o as needed.

By the above proposition, showing that the nonlocal operator \mathcal{P}_{sc} defined in (5.105) has trivial kernel is sufficient to prove that the system in (5.91) and (5.92) is uniquely solvable for every $\psi \in \mathcal{A}^{(0,k-1)}_{\delta-2}(M)$ and $\Gamma \in H^{k-1}(S^2)$. This will be the content of the next proposition.

Proposition 5.20. Fix $\delta \in (-1, -\frac{1}{2}]$. Let $u \in \mathcal{A}_{\delta}^{(2,k+1)}$ satisfy

(5.109)

Then $\tilde{u}=0$.

Proof. Similarly to what was done in the proof of lemma (3.3), we utilize the spherical symmetry of the conformal Schwarzschild metric to reduce the system in (5.91) and (5.92) to differential equations on the coefficients of \tilde{u} with respect to its spherical harmonics decomposition:

$$\tilde{u}(r,x) = \sum_{\ell=0}^{\infty} \sum_{m=-\ell}^{\ell} \tilde{a}_{m\ell}(r) Y_{m\ell}(x)$$
(5.110)

for $r \in [nm_0, \infty)$ and $x \in \partial M$.

We define the functions $a_{m\ell}(r) := \tilde{a}_{m\ell}(nm_0r)$ on $[1,\infty)$. Using the discussion in lemma (3.3), the condition $\|\tilde{u}\|_{\mathcal{A}^{(2,k+1)}_{\delta}} < \infty$ in particular implies $\|a_{m\ell}\|_{1,\delta} < \infty$ for every m and ℓ , where

$$\|a_{m\ell}\|_{1,\delta}^2 = \int_1^\infty r^{-2\delta+1} (a'_{m\ell}(r))^2 dr + \int_1^\infty r^{-2\delta-1} (a_{m\ell}(r))^2 dr \qquad (5.111)$$

The system in (5.91) and (5.92) as well as the condition $||a_{m\ell}||_{1,\delta} < \infty$ implies the following non-local differential equations on all the coefficients $\tilde{a}_{m\ell}(r)$:

r(r-2m_{0})\tilde{a}_{m\ell}^{"}(r) + 2(r-m_{0})\tilde{a}_{m\ell}^{'}(r) - \left(\frac{4m_{0}^{2}}{r(r-2m_{0})} + \ell(\ell+1)\right)\tilde{a}_{m\ell}(r) \\
= -\frac{2n(n-2)m_{0}^{3}}{r(r-2m_{0})}\left(\frac{4-n}{n(n-2)m_{0}}\tilde{a}_{m\ell}(nm_{0}) + \tilde{a}_{m\ell}^{'}(nm_{0})\right), \quad r \in [nm_{0}, +\infty) \\
\frac{2}{nm_{0}}\tilde{a}_{m\ell}^{'}(nm_{0}) - \frac{1}{n(n-2)m_{0}^{2}}(\ell(\ell+1) - \frac{2}{n})\tilde{a}_{m\ell}(nm_{0}) = 0, \\
\|a_{m\ell}\|_{1,\delta} < \infty
\end{cases}$$
(5.112)

The functions $a_{m\ell}$, using (5.112), satisfy the following similar non-local differential equations:

$$\begin{cases} r(r-\frac{2}{n})a''_{m\ell}(r) + 2(r-\frac{1}{n})a'_{m\ell}(r) - \left(\frac{4}{n^2r(r-\frac{2}{n})} + \ell(\ell+1)\right)a_{m\ell}(r) \\ = -\frac{2(n-2)}{n^2r(r-\frac{2}{n})}\left(\frac{4-n}{n-2}a_{m\ell}(1) + a'_{m\ell}(1)\right), \\ \frac{2}{n^2}a'_{m\ell}(1) - \frac{1}{n(n-2)}(\ell(\ell+1) - \frac{2}{n})a_{m\ell}(1) = 0, \\ \|a_{m\ell}\|_{1,\delta} < \infty \end{cases}$$

$$(5.113)$$

Note that the mass parameter m_0 does not appear in the non-local differential equation for $a_{m\ell}$. From here onwards we will study the system (5.113) instead of (5.112).

We consider (5.113) for any nonnegative integer ℓ and seek to derive that $a_{m\ell}(r)=0$ is the only solution. We consider the $\ell=0$ case separately. We replace the last condition in (5.113) with $a'_{m\ell}(1)=C$ and find the explicit (unique) solution to this shooting problem to be

$$a_{00}(r) = -C \frac{-2 + n + 6r - 3nr - 2nr^2 + n^2r^2}{r(nr - 2)},$$
 (5.114)

It then can easily be verified that $\lim_{r\to\infty} a_{00}(r) = 0$ if and only if C = 0, implying that $a_{00} = 0$ is the only solution to (5.113).

We conclude the only solutions to (5.113) in the $\ell=0$ case is the zero solution.

We now deal with the $\ell \geq 1$ case. We will write a_{ℓ} instead of $a_{m\ell}$ for simplicity.

Define the following constants:

$$lpha_\ell = rac{n^2}{n(2-\ell(\ell+1))-6}$$

Note that α_{ℓ} and β_{ℓ} are well defined for $\ell \geq 1$ and are both negative. Then the function a_{ℓ} solves the following initial value problem:

$$\begin{cases} r(r-\frac{2}{n})a_{\ell}''(r) + 2(r-\frac{1}{n})a_{\ell}'(r) - \left(\frac{4}{n^2r(r-\frac{2}{n})} + l(l+1)\right)a_{\ell}(r) = \frac{1}{r(r-\frac{2}{n})}C_{\ell} \\ a_{\ell}'(1) = \beta_{\ell}C_{\ell} \\ a_{\ell}(1) = \alpha_{\ell}C_{\ell} \end{cases}$$

If $C_\ell=0$, then $a_\ell=0$ by the existence and uniqueness theorem from ODE theory. Suppose now that $C_\ell\neq 0$. By considering $\frac{a_\ell}{C_\ell}$ instead of a_ℓ , we can assume without loss of generality that $C_\ell=1$.

We rewrite the system in the following way:

$$\begin{cases} \frac{d}{dr} \left[r(r - \frac{2}{n}) a'_{\ell}(r) \right] = \left(\frac{4}{n^2 r(r - \frac{2}{n})} + \ell(\ell + 1) \right) a_{\ell}(r) + \frac{1}{r(r - \frac{2}{n})} \\ a'_{\ell}(1) = \beta_{\ell} \\ a_{\ell}(1) = \alpha_{\ell} \end{cases}$$

We will show that a_{ℓ} blows up at infinity contradicting that $\|a_{\ell}\|_{1,\delta} < \infty$. This will then imply that $C_{\ell} = 0$ and hence $a_{\ell} = 0$. First, we prove a technical lemma.

Lemma 5.21. Let h_1, h_2 be smooth functions on $[1, \infty)$ such that h_1 is positive and $\lim_{r\to\infty} h_1(r) = C_1$ for some $C_1 > 0$. Let g be a function on $[1, \infty)$ satisfying the following ODE:

Then the following is true.

- Suppose that $h_2(r) \ge 0$ (≤ 0) on $[1,\infty)$ and that both $g(r_*)$ and $g'(r_*)$ are positive (negative) for some $r_* \in [1,\infty)$. Then g and g' are positive (negative) on (r_*,∞) .
- Suppose that g and g' are positive (negative) on (r_*, ∞) for some $r_* \in [1, \infty)$ and that $h_2(r) = O(r^{-2})$. Then $\lim_{r \to \infty} g(r) = \infty$ $(-\infty)$.

Proof. Suppose that h_2 is nonnegative everywhere. Let $r_* \in [1, \infty)$ be such that $g'(r_*) > 0$ and $g(r_*) > 0$. We will prove that g'(r) > 0 on (r_*, ∞) by using a simple bootstrap method. By continuity of g'(r), we know that g'(r) > 0 on $[r_*, r_* + \delta)$ for some $\delta > 0$. Then the set $B := \{r \in (r_*, \infty) \mid g'(s) > 0$ for $s \in [r_*, r)\}$ is nonempty. Suppose that $R := \sup B < \infty$. By continuity, we have that g'(R) = 0 and g'(r) > 0 for $r \in (r_*, R)$. Since $g(r_*) > 0$ and g is increasing on (r_*, R) , we have that g(R) > 0. By letting r = R in equation (5.117), it follows that $\frac{d}{dr}[r(r - 2/n)g']$ is positive at R and, in turn, on a neighbourhood of R. This implies that r(r - 2/n)g'(r) is increasing on a neighbourhood of R, which implies that 0 < r(r - 2/n)g'(r) < R(R - 2/n)g'(R) for r < R and close to R. As this contradicts that g'(R) = 0, we conclude that $\sup B = \infty$ and hence g' and g are positive on (r_*, ∞) .

Suppose now that g and g' are positive on (r_*, ∞) for some $r_* \in [1, \infty)$ and that $h_2(r) = O(r^{-2})$. In virtue of the positivity of g' and g as well as the monotone convergence theorem, it follows that $\lim_{r\to\infty} g(r)$ either is a positive number or is ∞ . Suppose that $\lim_{r\to\infty} g(r) = A > 0$, which in particular implies that g' is integrable.

By integrating equation (5.117), we get that

$$r(r-2/n)g'(r) = \frac{n-2}{n}g'(1) + \int_{1}^{r} [h_{1}(s)g(s) + h_{2}(s)]ds$$
 (5.118)

Using the fact that h_1 and g are O(1) and that $h_2(r) = O(r^{-2})$, it follows that $\sup_{r>1} rg'(r) < \infty$.

Furthermore, we have that

$$rg'(r) - g'(1) = \int_{1}^{r} [sg'(s)]'ds$$

$$= \int_{1}^{r} g'(s)ds + \int_{1}^{r} sg''(s)ds$$

(5.121)

It follows that there exists a constant M > 0 such that

$$\int_{1}^{r} \frac{h_{1}(s)g(s)}{s - 2/n} ds \le M \tag{5.122}$$

for any $r \in [1, \infty)$; since the integrand is positive, the limit as r tends to ∞ exists. In particular, this implies that $\frac{g}{r} \in L^1([1,\infty))$, which then contradicts that A is positive. Hence, we see that $\lim_{r\to\infty} g(r) = \infty$, as needed.

The case when h_2 is nonpositive is identical.

Corollary 5.22. *Let* h_1, h_2 *be smooth functions on* $[1, \infty)$ *such that* h_1 *is positive* and $\lim_{r\to\infty} h_1(r) = C_1$ for some $C_1 > 0$. Let g and \tilde{g} be functions on $[1,\infty)$ satisfying the following ODE:

$$\frac{d}{dr}\left[r(r-\frac{2}{n})g'(r)\right] = h_1(r)g(r) + h_2(r), \qquad \frac{d}{dr}\left[r(r-\frac{2}{n})\tilde{g}'(r)\right] = h_1(r)\tilde{g}(r) + h_2(r),$$

$$(5.123)$$

If $g(1) = \tilde{g}(1)$ and $g'(1) < \tilde{g}'(1)$, then $g(r) < \tilde{g}(r)$ for any $r \in (1, \infty)$.

Proof. Define $f := g - \tilde{g}$ and observe that f satisfies

$$\frac{d}{dr}\left[r(r-\frac{2}{n})f'(r)\right] = h_1(r)f(r) \tag{5.124}$$

Observe also that f(1) = 0 and f'(1) < 0. This in particular implies that there exists an $r_* > 1$ close enough to 1 such that f(r) and f'(r) are negative for any $r \in (1, r_*)$. By invoking lemma (5.21), we conclude that f(r) < 0 for any $r \in (1, \infty)$ as needed.

We now return to our goal of showing that a_{ℓ} blows up at ∞ .

We first decompose $a_{\ell} = f_{\ell} + g_{\ell}$ where f_{ℓ} solves

$$\begin{cases} \frac{d}{dr} \left[r(r - \frac{2}{n}) f'_{\ell}(r) \right] = \left(\frac{4}{n^2 r(r - \frac{2}{n})} + \ell(\ell + 1) \right) f_{\ell}(r) - \frac{4\alpha_{\ell}}{n^2 r(r - 2/n)} \\ f'_{\ell}(1) = 0 \\ f_{\ell}(1) = \alpha_{\ell} \end{cases}$$
(5.125)

and g_{ℓ} solves

$$\begin{cases} \frac{d}{dr} \left[r(r - \frac{2}{n}) g_{\ell}'(r) \right] = \left(\frac{4}{n^2 r(r - \frac{2}{n})} + \ell(\ell + 1) \right) g_{\ell}(r) + \frac{1 + (4/n^2) \alpha_{\ell}}{r(r - 2/n)} \\ g_{\ell}'(1) = \beta_{\ell} \\ g_{\ell}(0) = 0 \end{cases}$$
(5.126)

By letting r=1 in the equation for f_ℓ , we observe that $r(r-2/n)f'_\ell(r)$ is decreasing near r=1; since $f'_\ell(1)=0$, it follows that f_ℓ and f'_ℓ are negative near r=1. In particular, letting $\tilde{f}_\ell(r):=f_\ell(r)-\alpha_\ell$, we also have that \tilde{f}_ℓ and \tilde{f}'_ℓ are negative near r=1. Using the system in (5.125), we deduce that \tilde{f}_ℓ satisfies the following:

$$\begin{cases} \frac{d}{dr} \left[r(r - \frac{2}{n}) \tilde{f}'_{\ell}(r) \right] = \left(\frac{4}{n^2 r(r - \frac{2}{n})} + \ell(\ell + 1) \right) \tilde{f}_{\ell}(r) + \alpha_{\ell} \ell(\ell + 1) \\ \tilde{f}'_{\ell}(1) = 0 \\ \tilde{f}_{\ell}(1) = 0 \end{cases}$$

$$(5.127)$$

We invoke lemma (5.21) on \tilde{f}_{ℓ} to deduce that \tilde{f}_{ℓ} and \tilde{f}'_{ℓ} are negative on $(1,\infty)$. This in particular implies that $f_{\ell}(r)$ and $f'_{\ell}(r)$ are negative on $(1,\infty)$. We again invoke lemma (5.21) on f_{ℓ} to conclude that $\lim_{r\to\infty} f_{\ell}(r) = -\infty$.

It suffices to show that $g_{\ell}(r) < 0$ for all $r \in [1, \infty)$. We first observe from the definition of β_{ℓ} and α_{ℓ} that

$$\frac{\beta_{\ell}}{1 + (4/n^2)\alpha_{\ell}} = -\frac{n^2}{2(n-2)} \left(1 + \frac{2(n-2)}{n(\ell(\ell+1)-2)+2} \right)$$

for all n > 2 and $\ell \in \mathbb{N}$. In particular, we have that $1 + (4/n^2)\alpha_{\ell} > 0$ for every n > 2 and $\ell \in \mathbb{N}$.

Let \tilde{g}_{ℓ} be the function on $[1, \infty)$ solving

$$\begin{cases} \frac{d}{dr} \left[r(r - \frac{2}{n}) \tilde{g}'_{\ell}(r) \right] = \left(\frac{4}{n^2 r(r - \frac{2}{n})} + \ell(\ell + 1) \right) \tilde{g}_{\ell}(r) + \frac{1}{r(r - 2/n)} \\ \tilde{g}'_{\ell}(1) = -\frac{n^2}{2(n - 2)} \\ \tilde{g}_{\ell}(1) = 0 \end{cases}$$
(5.130)

In light of corollary (5.22) along with equation (5.129), it follows that the negativity of $\tilde{g}_{\ell}(r)$ on $(1,\infty)$ implies the negativity of $\frac{g_{\ell}(r)}{1+(4/n^2)\alpha_{\ell}}$ on $(1,\infty)$, which in turn implies that the negativity of $g_{\ell}(r)$ on $(1,\infty)$. It then suffices to show that $\tilde{g}_{\ell}(r) < 0$ on $(1,\infty)$.

We will prove that $\tilde{g}_{\ell}(r) < 0$ on $(1, \infty)$ by induction on ℓ . We first find the solution for $\ell = 0$ to be:

which is negative everywhere.

Now suppose that $\tilde{g}_{\ell}(r) < 0$ on $(1, \infty)$ for some nonnegative integer ℓ . Define $h_{\ell} := \tilde{g}_{\ell+1} - \tilde{g}_{\ell}$, which will solve:

$$\begin{cases} \frac{d}{dr} \left[r(r - \frac{2}{n}) h'_{\ell}(r) \right] = \left(\frac{4}{n^2 r(r - \frac{2}{n})} + (\ell + 1)(\ell + 2) \right) h_{\ell}(r) + 2(\ell + 1) \tilde{g}_{\ell}(r) \\ h'_{\ell}(1) = 0 \\ h_{\ell}(1) = 0 \end{cases}$$

(5.132)

We directly compute $h''_{\ell}(1) = \frac{n}{n-2}2(\ell+1)\tilde{g}_{\ell}(1) = 0$ and $h'''_{\ell}(1) = \frac{n}{n-2}2(\ell+1)\tilde{g}'_{\ell}(1) < 0$. This then implies that h_{ℓ} and h'_{ℓ} are negative near r=1. Using the fact that $\tilde{g}_{\ell}(r) < 0$ on $(1,\infty)$ and invoking lemma (5.21), it follows that $h_{\ell}(r) < 0$ on $(1,\infty)$, which in turn implies that $\tilde{g}_{\ell+1}(r) < 0$ on $(1,\infty)$ as needed.

We have finally shown that a_{ℓ} blows up at infinity for every $\ell \in \mathbb{N}$ contradicting that $\|a_{\ell}\|_{1,\delta} < \infty$. We conclude that the assumption that $C_{\ell} \neq 0$ was false and hence $a_{\ell} = 0$ for every $\ell \in \mathbb{N}$ and, in turn, $\tilde{u} = 0$.

This concludes Step 1, and we move on to Step 2.

Step 2: Solving for \tilde{g} and $\tilde{\omega}$

Let $\tilde{u} \in \mathcal{A}_{\delta}^{(2,k+1)}$ be the function satisfying equations (5.91) and (5.92) with ψ and Γ given by equations (5.93) and (5.94). We wish to show that there exists a unique $\tilde{g} \in T_{g_{sc}}\mathcal{M}_{\delta}^k$ and a conformal Killing field $\tilde{\omega}$ satisfying equations (5.83) to (5.85) and (5.87) to (5.90).

Equation (5.90) determines uniquely the initial data for \widetilde{trK} , which is given by

$$\widetilde{trK}\Big|_{\partial M} = H + 2\partial_r \tilde{u}|_{\partial M} - \frac{2}{nm_0} \tilde{u}|_{\partial M}$$
 (5.133)

and is living in $H^k(\partial M)$. We rewrite the ODE (5.84) obeyed by \widetilde{trK} here for convenience.

$$\partial_r \widetilde{trK} + trK_{sc}\widetilde{trK} + 4(\partial_r u_{sc})(\partial_r \widetilde{u}) = B$$
, on M

which, together with the initial condition in (5.133), determines uniquely \widetilde{trK} on M. We explicitly solve for \widetilde{trK} on M to get:

$$\widetilde{trK}(r,p) = \frac{n(n-2)m_0^2}{r(r-2m_0)} \widetilde{trK}\Big|_{\partial M}(p) - \frac{4m_0}{r(r-2m_0)} \Big(\widetilde{u}(r,p) - \widetilde{u}|_{\partial M}(p)\Big) + \frac{1}{r(r-2m_0)} \int_{nm_0}^r s(s-2m_0)B(s,p)ds$$
for $r \in [nm_0, \infty)$ and $p \in S^2$.

We observe that

- $(\partial_r u_{sc})(\partial_r \tilde{u}) \in L^2_{\delta-2}([nm_0,\infty); H^k(S^2))$
- $B \in L^2_{\delta-2}([nm_0,\infty); H^k(S^2)).$

and so \widetilde{trK} lies in $H^1_{\delta-1}([nm_0,\infty);H^k(S^2))$.

We turn our attention to \widetilde{K} . We first recall the well known fact regarding the divergence operator on symmetric traceless tensors on S^2 (see [CK93]).

Proposition 5.23. Let $k \geq 2$. Let γ be a smooth metric on S^2 with positive curvature. Denote by $\mathcal{D}^k(S^2)$ the space of traceless symmetric (0,2) tensors on (S^2,γ) with components in $H^k(S^2)$. Let $\Omega^{\perp^{k-1}}(\partial M)$ be the space of vector fields on S^2 with components in $H^{k-1}(M)$ that are L^2 orthogonal to conformal Killing vector fields on (S^2,γ) . Then the divergence operator $\operatorname{div}_{\gamma}$ is an isomorphism from $\mathcal{D}^k(S^2)$ to $\Omega^{\perp^{k-1}}(S^2)$

The above proposition along with equation (5.88) imply that $\frac{2}{n(n-2)m_0} d\tilde{u} + \tilde{\omega} - F$ must be orthogonal to conformal Killing vector fields on $(\partial M, \gamma_{sc})$. Since $\tilde{\omega}$ is conformal Killing on $(\partial M, \gamma_{sc})$, this requirement determines $\tilde{\omega}$ uniquely. Indeed, if $Y_1, ..., Y_6$ is an L^2 orthonormal basis of conformal Killing vector fields, then $\tilde{\omega}$ must be

The above proposition together with (5.88) determine uniquely the initial condition for \widetilde{K} to be

ight)$$
 (5.136)

living in $\mathcal{H}^k(\partial M)$. We rewrite the ODE (5.85) obeyed by \widetilde{K} here for convenience.

$$\mathcal{L}_{\frac{\partial}{\partial r}}\widetilde{\hat{K}}=C$$
, on M

which, together with the initial condition in (5.136), determines \hat{K} uniquely on M. Fixing fermi coordinates, (r, θ^1, θ^2) , we explicitly solve for \hat{K} on M to get:

$$\hat{K}_{ij}(r,p) = \left. \widetilde{\hat{K}}_{ij} \right|_{\partial M} + \int_{nm_0}^r C_{ij}(s,p) \tag{5.137}$$

for $i, j = 1, 2, r \in [nm_0, \infty)$ and $p \in S^2$.

Since $C \in L^2_{\delta-2}([nm_0,\infty);\mathcal{H}^k(S^2))$, it follows that \hat{K} lies in $H^1_{\delta-1}([nm_0,\infty);\mathcal{H}^k(S^2))$.

Equation (5.89) determines uniquely initial date for \tilde{g} given by

$$\tilde{g}|_{\partial M} = \frac{n-2}{n} \left(2n^2 m_0^2 \, \tilde{u} \, \gamma_{S^2} + G \right)$$
(5.138)

living in $\mathcal{H}^k(\partial M)$. The evolution of \tilde{g} is determined by \widetilde{trK} and \widetilde{K} in the following equation:

$$\mathcal{L}_{\frac{\partial}{\partial r}}\tilde{g} = 2\widetilde{K} + \widetilde{trK}g_{sc} + trK_{sc}\,\tilde{g} \tag{5.139}$$

Equations (5.139) and (5.138) determine uniquely \tilde{g} to be, in fermi coordinates (r, θ^1, θ^2) ,

$$\tilde{g}_{ij} = r(r - 2m_0) \int_{nm_0}^{r} \frac{1}{s(s - 2m_0)} \left(2\tilde{K}_{ij} + \widetilde{trK} g_{sc_{ij}} \right) ds + \frac{r(r - 2m_0)}{nm_0^2} G_{ij}$$
(5.140)

In light of the fact that $\widetilde{trK} \in H^1_{\delta-1}\left([nm_0,\infty);H^k(S^2)\right)$ and $\widetilde{K} \in H^1_{\delta-1}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$, it follows \widetilde{g} is of the form $\widetilde{g}=r^2(G+h(r))$ where $G\in\mathcal{H}^k(S^2)$ and $h\in H^2_{\delta}\left([nm_0,\infty);\mathcal{H}^k(S^2)\right)$; this implies that $\widetilde{g}\in T_{g_{SC}}\mathcal{M}^k_{\delta}$ as needed.

We have then shown that there exists a unique \tilde{g} and $\tilde{\omega}$ satisfying equations (5.84), (5.85) and (5.87) to (5.90). It follows by lemma (5.16) that equation (5.83) is satisfied as well. This concludes Step 2, and we move on to Step 3.

Step 3: Solving for \tilde{X}

We wish to show that there exists a unique $\tilde{Y} \in \hat{\mathcal{X}}^2_{\delta}(M)$ satisfying

$$\Delta_{g_{sc,conf}}\tilde{Y} = D \tag{5.141}$$

where $D \in \mathcal{X}^0_{\delta-2}(M)$. Similar results have been shown in [Maxo5] for the above equation with trivial Dirichlet and Neumann conditions. In our case, vector fields Y in $\widehat{\mathcal{X}}^2(M)$ satisfy the following mixed boundary conditions

The isomorphism of the operator $\Delta_{g_{sc},conf}$ in our space follows by minor modifications of the proof in [Maxo5]. We add the proof here for the sake of completeness.

Proposition 5.24. Let $\delta \in (-1, -\frac{1}{2}]$. The operator $\Delta_{g_{sc},conf}$ is an isomorphism from $\widehat{\mathcal{X}}^2_{\delta}(M)$ to $\mathcal{X}^0_{\delta-2}(M)$.

Let $X \in \widehat{\mathcal{X}}^2_{\delta}(M)$ satisfy $\Delta_{g_{sc},conf}X = 0$. Given $R \geq nm_0$, let ϕ_R be a cutoff function on $[nm_0,\infty)$ satisfying $\phi_R(x) = 1$ for $x \leq R$, $\phi_R(x) = 0$ for $x \geq R+1$, and $-2 \leq \phi_R'(x) \leq 0$ for any $x \in [nm_0,\infty)$.

We integrate by parts to get

$$0 = \int_{M} \phi_{R} X^{\mu} \Delta_{g_{sc},conf} X_{\mu} dV_{g_{sc}}$$

$$= -\frac{1}{2} \int_{M} \left(\mathcal{L}_{g_{sc},conf} \phi_{R} X \right) \cdot \left(\mathcal{L}_{g_{sc},conf} X \right) dV_{g_{sc}} - \int_{\partial M} \mathcal{L}_{g_{sc},conf} X (X, \frac{\partial}{\partial r}) d\sigma_{g_{sc}(nm_{0})}$$

$$(5.148)$$

$$= -\frac{1}{2} \int_{M} \phi_{R} \left| \mathcal{L}_{g_{sc},conf} X \right|^{2} dV_{g_{sc}} - \frac{1}{2} \int_{M} 2\phi_{R}' \mathcal{L}_{g_{sc},conf} X (X, \frac{\partial}{\partial r}) dV_{sc}$$

$$(5.149)$$

This implies that for any $R \ge nm_0$,

$$\int_{B_R \setminus B_{nm_0}} \left| \mathcal{L}_{g_{sc},conf} X \right|^2 dV_{g_{sc}} \le \int_M \phi_R \left| \mathcal{L}_{g_{sc},conf} X \right|^2 dV_{g_{sc}}$$
(5.150)

$$= -\int_{M} 2\phi_{R}' \mathcal{L}_{g_{sc},conf} X(X, \frac{\partial}{\partial r}) dV_{sc} \qquad (5.151)$$

$$\leq 4 \int_{B_{R+1}\setminus B_R} |\mathcal{L}_{g_{sc},conf} X(X,\frac{\partial}{\partial r})| dV_{sc}$$
 (5.152)

$$\lesssim \int_{B_{R+1}\setminus B_R} |\nabla X|^2 dV_{sc} \tag{5.153}$$

Since $\delta \in (-1, -\frac{1}{2})$, we have that $|\nabla X|^2 \leq |\nabla X|^2 r^{-2\delta-1}$ and so $|\nabla X|^2$ is integrable on M and $\int_M |\nabla X|^2 dV_{sc} \leq \|\nabla X\|_{0,\delta-1}^2$. We can then take the limit as R goes to infinity in the above equations to deduce that

implying that X is conformal Killing on (M, g_{sc}) . Since the equation $\Delta_{g_{sc},conf}X=0$ is an elliptic PDE with smooth coefficients, elliptic reg-

ularity shows that X is C^{∞} . We can then invoke lemma 5.14 to conclude that X=0, which shows that the kernel of $\Delta_{g_{sc},conf}$ is trivial.

Now we show that the kernel of the adjoint is also trivial. It will then follow that $\Delta_{g_{sc,conf}}$ is an isomorphism. Recall that

, $J(Y): X \in \mathcal{X}^0_{\tau}(M) \mapsto \int_M X \cdot Y r^{-2\tau - 3} dV_{g_{sc}}$

where \cdot is with respect to g_{sc} . For simplicity of the notation, we will denote both Y and J(Y) by Y; it will be clear from context which one we are referring to.

We then have that $Y \in (\mathcal{X}^0_{\delta-2}(M))^*$ is in the kernel of $\Delta^*_{g_{sc},conf}$ if and only if

$$\int_{M} Y \cdot \Delta_{g_{sc},conf} X \ r^{-2(\delta-2)-3} dV_{g_{sc}} = 0$$
 (5.155)

for every $X \in \widehat{\mathcal{X}}^2_{\delta}(M)$, which is equivalent to the above equation holding for every smooth compactly supported vector field X in $\widehat{\mathcal{X}}^2_{\delta}(M)$ by a density argument.

It follows from elliptic regularity that $Y \in \mathcal{X}^2_{\delta-2}(M)$. In fact, Y will be smooth since the metric g_{sc} is smooth. Given an arbitrary smooth compactly supported vector field X in $\widehat{\mathcal{X}}^2_{\delta}(M)$, we can then integrate by parts to get

where $\bar{Y}:=r^{-2(\delta-2)-3}Y$, $X_0:=g_{sc}(\frac{\partial}{\partial r},X)$ and $\bar{Y}_0:=g_{sc}(\frac{\partial}{\partial r},\bar{Y})$. Note that the boundary terms vanish at infinity since X is compactly supported. Since X was an arbitrary vector field in a dense subset of $\widehat{\mathcal{X}}^2_{\delta}(M)$, it follows that \bar{Y} satisfies

$$\Delta_{g_{sc},conf}\bar{Y} = 0, \quad g(\frac{\partial}{\partial r},\bar{Y}) = 0, \quad \left(\mathcal{L}_{\frac{\partial}{\partial r}}\bar{Y}\right)^T = 0$$
(5.160)

Considering that $Y \in \mathcal{X}^0_{\delta-2}(M)$, it follows that $\bar{Y} \in \widehat{\mathcal{X}}^2_{-\delta-1}(M)$. Since $\Delta_{g_{sc},conf}\bar{Y}=0$ and $-1<-\delta-1<0$, we have that $Y \in \widehat{\mathcal{X}}^2_{\tau}(M)$ for any $\tau \in (-1,0)$ (see [CBo8] and [Bar86]). We can then apply the same integration-by-parts argument carried out earlier to conclude that \bar{Y} is conformal Killing on (M,g_{sc}) and hence, by lemma (5.14), vanishes as needed.



APPENDIX

A.1 A PDE OF FINITE TYPE FOR CONFORMAL KILLING VECTOR FIELDS

In this section, we will prove an identity satisfied by conformal Killing vector fields that is used in the proof of lemma 5.14. More specifically, we will prove that any conformal Killing vector field Z on an arbitrary n-dimensional Riemannian manifold (M,g) satisfies the following PDE of finite type:

$$\nabla^3 Z = A \cdot \nabla Z + B \cdot Z \tag{A.1}$$

where *A* and *B* are linear expressions in *Riem* and ∇ *Riem*.

Let *Z* be a conformal Killing field and let $\psi := \frac{2}{n} \text{div} Z$. The conformal Killing equation is

$$\nabla_i Z_i + \nabla_i Z_i = \psi g_{ij} \tag{A.2}$$

Eisenhart in [Eis49] (see pages 231-232 in [Eis49]) proves the following identities:

$$\nabla_k \nabla_j Z_i = -Z_m R_{kij}^m + \frac{1}{2} (g_{ij} \nabla_k \psi + g_{ik} \nabla_j \psi - g_{jk} \nabla_i \psi)$$
 (A.3)

$$g^{il}Z_m\nabla_lR_{kij}^m - Z_m\nabla_kR_j^m - \nabla_kZ_mR_j^m - \nabla_jZ_mR_k^m + \frac{n-2}{2}\nabla_k\nabla_j\psi + \frac{1}{2}g_{jk}\Delta\psi = 0$$
(A.4)

where R denotes Riem or Ric depending on the number of indices. Taking the trace of equation (A.4), we get

$$\Delta \psi = \frac{2}{n-1} \left(Z_m \nabla_i R^{mi} + \nabla_i Z_m R^{mi} \right) \tag{A.5}$$

Using equation (A.5) to eliminate $\Delta \psi$ in equation (A.4), we get the following expression of $\nabla_k \nabla_j \psi$:

$$\nabla_k \nabla_j \psi = \frac{2}{n-2} \left(-g^{il} Z_m \nabla_l R_{kij}^m + Z_m \nabla_k R_j^m + \nabla_k Z_m R_j^m + \nabla_j Z_m R_k^m - \frac{1}{n-1} g_{jk} \left(Z_m \nabla_i R^{mi} + \nabla_i Z_m R^{mi} \right) \right)$$
(A.6)

Taking a derivative of equation (A.3) and using equation (A.6), we get the desired result.

A.2 A HARDY-TYPE INEQUALITY

In this section, we will prove a Hardy-type inequality that is used in the proof of lemma 5.14, namely equation (5.75).

Let $g \in \mathcal{M}^k_{\delta}(M)$ be a Riemannian metric on $M = [nm_0, \infty) \times S^2$ of the form

$$g = dr^2 + r^2(\gamma_\infty + h(r))$$

where γ_{∞} is a metric on S^2 and $h \in H^2_{\delta}([nm_0, \infty); \mathcal{H}^k(S^2))$. We will prove the following.

Proposition A.1. There exists an $R_0 > nm_0$ depending only on g such that for $R \ge R_0$ and $\tau > 0$, the inequality

$$\int_{[R,\infty)\times S^2} r^{\tau-2} |T|^2 dV_g \le \frac{4}{\tau^2} \int_{[R,\infty)\times S^2} r^{\tau} |\nabla T|^2 dV_g \tag{A.7}$$

holds for all tensor fields $T \in C^1_c(M)$.

Proof. The main tool we will use is a general L^p Hardy inequality in Riemannian manifolds developed by D'Ambrosio and Dipierro in [DD12]. We present the relevant version of it below.

Theorem A.2. Let $\rho \in C^2(M)$ such that $\Delta_g \rho \geq 0$ such that $\frac{|\nabla \rho|^2}{\Delta \rho} \in L^1_{loc}(M)$. Then for any $R > nm_0$, the inequality

$$\int_{[R,\infty)\times S^2} |u|^2 \Delta \rho \, dV_g \le 4 \int_{[R,\infty)\times S^2} \frac{|\nabla \rho|^2}{\Delta \rho} |\nabla u|^2 dV_g \tag{A.8}$$

holds for all $u \in C_c^1(M)$.

Letting $\rho = r^{\tau}$ for $\tau > 0$, we compute

$$\Delta \rho = \tau r^{\tau - 2} \left[\tau + 1 + r \left(trK - \frac{2}{r} \right) \right], \quad |\nabla \rho|^2 = \tau^2 r^{2\tau - 2}$$
 (A.9)

In light of the Sobolev embeddings in proposition 2.10, we have that

$$|trK - \frac{2}{r}| = o(r^{-1+\delta})$$
 (A.10)

So we can choose $R_0 > nm_0$ depending only on g such that for any $R \ge R_0$,

$$\left| r \left(trK - \frac{2}{r} \right) \right| \le 1 \tag{A.11}$$

This, in turn, implies that for any $\tau > 0$ and any $R \ge R_0$,

$$\Delta \rho \ge \tau^2 r^{\tau - 2} \ge 0 \tag{A.12}$$

on $[R, \infty) \times S^2$.

We can then invoke theorem A.2 directly to deduce that the inequality

$$\int_{[R,\infty)\times S^2} r^{\tau-2} |u|^2 dV_g \le \frac{4}{\tau^2} \int_{[R,\infty)\times S^2} r^{\tau} |\nabla u|^2 dV_g \tag{A.13}$$

hold for any $R \ge R_0$ and $u \in C_c^1(M)$.

The same inequality holds with u replaced with a tensor field T. To see this, we first compute that for any tensor field T on M,

$$|\nabla |T||^2 \le |\nabla T|^2 \tag{A.14}$$

Using the above and letting u = |T| in equation (A.13), we immediately deduce that the inequality

$$\int_{[R,\infty)\times S^2} r^{\tau-2} |T|^2 dV_g \le \frac{4}{\tau^2} \int_{[R,\infty)\times S^2} r^{\tau} |\nabla T|^2 dV_g \tag{A.15}$$

holds for any $R \ge R_0$ and tensor field $T \in C_c^1(M)$.

Corollary A.3. Let $\delta \in (-1, -\frac{1}{2})$. There exists an $R_0 > nm_0$ depending only on g and a positive constant C depending only on δ such that for any $R \geq R_0$ and any vector field $Z \in \mathcal{X}^3_{\delta}(M)$,

$$\int_{[R,\infty)\times S^2} r^{-2\delta-3} (|Z|^2 + r^2 |\nabla Z|^2) dV_g \le C \int_{[R,\infty)\times S^2} r^{-2(\delta-3)-3} |\nabla^3 Z|^2 dV_g$$
(A.16)

Proof. By repeatedly applying proposition A.1 for $\tau = -2\delta - 1, -2\delta +$ $1, -2\delta + 3$ and $T = Z, \nabla Z, \nabla^2 Z$, we deduce that there exists a positive constant $C = C(\delta)$ such that

$$\int_{[R,\infty)\times S^2} r^{-2\delta-3} (|Z|^2 + r^2 |\nabla Z|^2) dV_g \le C \int_{[R,\infty)\times S^2} r^{-2(\delta-3)-3} |\nabla^3 Z|^2 dV_g$$
(A.17)

for any $R \ge R_0$ and any vector field $Z \in C_c^3(M)$. The above inequality can be rewritten in terms of the norm on $\mathcal{X}_{\delta}^{k}(M)$ (see definition 2.5) as follows:

$$||Z||_{1,\delta}^2 \le C ||\nabla^3 Z||_{0,\delta-3}^2 \tag{A.18}$$

The desired inequality then follows from the density of $C_c^3(M)$ in $\mathcal{X}_{\delta}^3(M)$.

THE LEGENDRE FUNCTIONS P_ℓ AND Q_ℓ

In this section, we will prove properties of the Legendre functions of the first and second kind, P_{ℓ} and Q_{ℓ} , that are used in the proof of lemma 3.3.

Fix R > 1 (which is n - 1 in chapter 3). For a positive integer ℓ , as described by Olver in [OR14], the Legendre functions, P_{ℓ} and Q_{ℓ} , are linearly independent solutions to the ODE

$$(z^2 - 1)h''(z) + 2zh'(z) - \ell(\ell + 1)h(z) = 0, \quad z \in [R, \infty)$$
(A.19)

with the following asymptotics as $z \to \infty$,

$$P_{\ell}(z) = O(z^{\ell}), \quad Q_{\ell}(z) = O(z^{-\ell-1})$$
 (A.20)

We normalize P_{ℓ} and Q_{ℓ} so that

$$\lim_{z \to \infty} z^{-\ell} P_{\ell}(z) = 1, \quad \lim_{z \to \infty} z^{\ell+1} Q_{\ell}(z) = 1 \tag{A.21}$$

which is different than Olver's. Letting \mathbf{P}_{ℓ} and \mathbf{Q}_{ℓ} be the Legendre functions as defined by Olver, the relation between ours and his can immediately be obtained is as follows (see [OR14] chapter 5 section 12 and 13):

$$P_{\ell}(z) = \frac{\sqrt{\pi}\Gamma(\ell+1)}{2^{\ell}\Gamma(\ell+\frac{1}{2})} \mathbf{P}_{\ell}(z), \quad Q_{\ell}(z) = \frac{2^{\ell+1}\Gamma(\ell+\frac{3}{2})}{\sqrt{\pi}\Gamma(\ell+1)} \mathbf{Q}_{\ell}(z)$$
(A.22)

In the following proposition, we will apply the method of Frobenius to obtain the expansion of P_{ℓ} and Q_{ℓ} in terms of powers of z.

Proposition A.4. P_{ℓ} and Q_{ℓ} admit an expansion of the following form. For z > 1,

$$P_{\ell}(z) = \sum_{k=0}^{\ell} a_k z^{\ell-k}, \quad Q_{\ell}(z) = \sum_{k=0}^{\infty} b_k z^{-\ell-1-k}$$
 (A.23)

where the coefficients a_k and b_k are defined recursively as follows:

$$a_0=b_0=1,\quad a_1=b_1=0$$
 for $k\geq 2$, $a_k=\frac{(\ell-k+2)(\ell-k+1)}{k^2-k(2\ell+1)}a_{k-2}$, $b_k=\frac{(\ell+k-1)(\ell+k)}{k(2\ell+k+1)}b_{k-2}$

The expansion of P_{ℓ} and Q_{ℓ} as described above agree with [WW96] pg 302 and 320.

Proposition A.5. There exists a constant C = C(R) such that for any $\ell \ge 1$ and $z \in [R, \infty)$, the following holds

$$\begin{aligned} z^{-\ell}|P_{\ell}(z)| &\leq C \left(\frac{2z}{z+\sqrt{z^2-1}}\right)^{-\ell}, & z^{\ell+1}|Q_{\ell}(z)| \leq C \left(\frac{2z}{z+\sqrt{z^2-1}}\right)^{\ell} \\ z^{-(\ell-1)}|P'_{\ell}(z)| &\leq C\ell \left(\frac{2z}{z+\sqrt{z^2-1}}\right)^{-\ell}, & z^{\ell+2}|Q'_{\ell}(z)| \leq C\ell \left(\frac{2z}{z+\sqrt{z^2-1}}\right)^{\ell} \\ & (\text{A.24}) \end{aligned}$$

Proof. Olver, in [OR14] chapter 12 section 12, has established an asymptotic expansion of \mathbf{P}_{ℓ} and \mathbf{Q}_{ℓ} for large degree ℓ that is uniformly valid for $z \in (1, \infty)$. Shivakumar and Wong, in [SW88], proved an equivalent expansion of \mathbf{P}_{ℓ} that is more computable; letting $u = \ell + 1/2$, he has shown that for $\xi > 0$,

$$\mathbf{P}_{\ell}(\cosh \xi) = \left(\frac{\xi}{\sinh \xi}\right)^{1/2} \left(I_0(u\xi) + \epsilon(u,\xi)\right) \tag{A.26}$$

where

$$|\epsilon(u,\xi)| \le \frac{\Gamma(3/2)}{2\Gamma(1/2)} \frac{2\xi}{1+\xi} \frac{I_1(u\xi)}{u} \tag{A.27}$$

and I_0 , I_1 are the modified Bessel functions (see [OR14] chapter 2 section 10).

Similarly, Frenzen, in [Fre90], proved an equivalent expansion of \mathbf{Q}_{ℓ} that is more computable than Olver's; he has shown that for $\xi > 0$,

$$\mathbf{Q}_{\ell}(\cosh \xi) = \left(\frac{\xi}{\sinh \xi}\right)^{1/2} \left(K_0(u\xi) + \eta(u,\xi)\right) \tag{A.28}$$

where

$$|\eta(u,\xi)| \le \frac{\xi}{2(2+\xi)} \frac{K_1(u\xi)}{u} \tag{A.29}$$

and K_0 , K_1 are the modified Bessel functions (see [OR14] chapter 7 section 8)

Letting ξ_0 be the positive number in which $\cosh \xi_0 = R$, Olver's asymptotics of the modified Bessel function in [OR14] chapter 12, section 1 implies that for all $\xi \geq \xi_0$,

$$|I_0(u\xi)| + |I_{-1}(u\xi)| \le C \frac{e^{u\xi}}{2\pi\sqrt{u\xi}}, \quad |K_0(u\xi)| + |K_1(u\xi)| \le C \left(\frac{\pi}{2u\xi}\right)^{1/2} e^{-u\xi}$$
(A.30)

for some constant C > 0 depending only on R. We can then compute for $\xi \in [\xi_0, \infty)$,

$$\begin{split} (\cosh\xi)^{-\ell}|P_{\ell}(\cosh\xi)| &= \frac{\sqrt{\pi}\Gamma(\ell+1)}{2^{\ell}\Gamma(\ell+\frac{1}{2})}(\cosh\xi)^{-\ell}|\mathbf{P}_{\ell}(\cosh\xi)| &\qquad (\mathrm{A}.31) \\ &\leq C\frac{\sqrt{\pi}\Gamma(\ell+1)}{2^{\ell}\Gamma(\ell+\frac{1}{2})}2^{\ell}(e^{\xi}+e^{-\xi})^{-\ell}\frac{\sqrt{2\xi}}{\sqrt{e^{\xi}-e^{-\xi}}}\frac{e^{(\ell+1/2)\xi}}{2\pi\sqrt{(\ell+1/2)}\sqrt{\xi}} \\ &\leq C\frac{\Gamma(\ell+1)}{\Gamma(\ell+\frac{1}{2})}\frac{1}{\sqrt{\ell}}\left(\frac{e^{\xi}}{e^{\xi}-e^{-\xi}}\right)^{1/2}\left(\frac{e^{\xi}}{e^{\xi}+e^{-\xi}}\right)^{\ell} &\qquad (\mathrm{A}.33) \\ &\leq C\frac{\Gamma(\ell+1)}{\Gamma(\ell+\frac{1}{2})}\frac{1}{\sqrt{\ell}}\left(\frac{e^{\xi}}{e^{\xi}+e^{-\xi}}\right)^{\ell} &\qquad (\mathrm{A}.34) \end{split}$$

$$\begin{aligned} (\cosh \xi)^{\ell+1} |Q_{\ell}(\cosh \xi)| &= \frac{2^{\ell+1} \Gamma(\ell + \frac{3}{2})}{\sqrt{\pi} \Gamma(\ell + 1)} (\cosh \xi)^{\ell+1} |\mathbf{Q}_{\ell}(\cosh \xi)| & (A.35) \\ &\leq C \frac{2^{\ell+1} \Gamma(\ell + \frac{3}{2})}{\sqrt{\pi} \Gamma(\ell + 1)} 2^{-\ell-1} (e^{\xi} + e^{-\xi})^{\ell+1} \frac{\sqrt{2\xi}}{\sqrt{e^{\xi}} - e^{-\xi}} \left(\frac{\pi}{2(\ell + 1/2)\xi} \right)^{1/2} e^{-(\ell + 1/2)\xi} \\ & (A.36) \end{aligned}$$

$$&\leq C \frac{\Gamma(\ell + \frac{3}{2})}{\Gamma(\ell + 1)} \frac{1}{\sqrt{\ell}} \left(\frac{e^{\xi}}{e^{\xi} - e^{-\xi}} \right)^{1/2} \left(\frac{e^{\xi} + e^{-\xi}}{e^{\xi}} \right)^{\ell+1} (A.37)$$

$$&\leq C \frac{\Gamma(\ell + \frac{3}{2})}{\Gamma(\ell + 1)} \frac{1}{\sqrt{\ell}} \left(\frac{e^{\xi} + e^{-\xi}}{e^{\xi}} \right)^{\ell} (A.38)$$

where we have allowed the constant C to change from line to line but remains dependent only on R and not on ξ or ℓ .

In light of Stirling's formula (see [OR14], chapter 3, section 8), the Gamma function enjoys the following asymptotics:

$$\Gamma(x) = e^{-x} x^{x} (1 + \mathcal{O}(x^{-1})), \text{ as } x \to \infty$$
 (A.39)

In particular, we have

$$\frac{\Gamma(\ell+1)}{\Gamma(\ell+\frac{1}{2})} = \left(1 + \frac{1}{2(\ell+1/2)}\right)^{\ell+1/2} \frac{\sqrt{\ell+1}}{\sqrt{e}} (1 + \mathcal{O}(\ell^{-1})) \tag{A.40}$$

and

$$\frac{\Gamma(\ell+\frac{3}{2})}{\Gamma(\ell+1)} = \left(1 + \frac{1}{2(\ell+1)}\right)^{\ell+1} \frac{\sqrt{\ell+\frac{3}{2}}}{\sqrt{e}} (1 + \mathcal{O}(\ell^{-1})) \tag{A.41}$$

as $\ell \to \infty$. It then follows that $\frac{\Gamma(\ell+1)}{\Gamma(\ell+\frac{1}{2})}\frac{1}{\sqrt{\ell}}$ and $\frac{\Gamma(\ell+\frac{3}{2})}{\Gamma(\ell+1)}\frac{1}{\sqrt{\ell}}$ are bounded for $\ell \geq 1$, and we finally conclude that there exists a constant C depending only on R such that for any $z \geq R$,

$$z^{-\ell}P_{\ell}(z) \le C \left(\frac{2z}{z + \sqrt{z^2 - 1}}\right)^{-\ell}, \quad z^{\ell + 1}Q_{\ell}(z) \le C \left(\frac{2z}{z + \sqrt{z^2 - 1}}\right)^{\ell} \tag{A.42}$$

where we used

$$\frac{e^{\xi} + e^{-\xi}}{e^{\xi}} = \frac{2z}{z + \sqrt{z^2 - 1}}$$
 (A.43)

for $z = \cosh \xi$.

We have then shown equation (A.24). The estimate for P'_{ℓ} and Q'_{ℓ} in equation (A.25) follows immediately from equation (A.24) and the recurrence relations (see [BE55] pg 161 and [WW96] pg 318)

$$(z^{2}-1)P'_{\ell}(z) = \ell(zP_{\ell}(z) - P_{\ell-1}(z)), \quad (z^{2}-1)Q'_{\ell}(z) = \ell(zQ_{\ell}(z) - Q_{\ell-1}(z))$$
(A.44)
